

## RESOLUTION No. 2014-036

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, WITH THE JAPAN INTERNATIONAL COOPERATION AGENCY (JICA), THRU ITS CHIEF REPRESENTATIVE, MR. TAKAHIRO SASAKI, AND THE PHILIPPINE NATIONAL VOLUNTEER SERVICE COORDINATING AGENCY (PNVSCA), TO PROMOTE AND SUPPORT THE ACTIVITIES OF CITY DISASTER RISK REDUCTION MANAGEMENT COUNCIL (CDRRMC) IN ORMOC CITY AND TO CONNECT THE CDRRMC'S INITIATIVES WITH VARIOUS LOCAL STAKEHOLDERS INCLUDING COMMUNITY LEVEL.

WHEREAS, this Sanggunian received an Urgent Indorsement dated February 19, 2014 from the Office of the City Mayor anent the Memorandum of Agreement (MOA) to be entered into by and among the Japan International Cooperation Agency (JICA), thru its Chief Representative, Mr. Takahiro Sasaki, the Philippine National Volunteer Service Coordinating Agency, and the Local Government Unit of Ormoc, and further requesting that the Honorable City Mayor be granted the authority to sign the same for and in behalf of the City Government of Ormoc to promote and support the activities of City Disaster Risk Reduction Management Council (CDRRMC) in Ormoc City and to connect the CDRRMC'S initiatives with various local stakeholders including community level;

WHEREAS, LGU-Ormoc is mandated to serve primarily as a general purpose government for the coordination and delivery of basic, regular and direct services and effective governance of the inhabitants within its territorial jurisdiction;

WHEREAS, the Japan International Cooperation Agency (JICA) is aimed at providing Japanese volunteers in developing countries and in this regard shall coordinate and deploy a JICA volunteer to LGU-Ormoc to support the activity of CDRRMC and to connect CDRRMC's initiatives with various local stakeholders including community level;

WHEREAS, the Philippine National Volunteer Service Coordinating Agency (PNVSCA) is a government agency mandated to coordinate the national volunteer service program in the Philippines and act as clearinghouse for international volunteer services;

WHEREAS, the aforementioned parties have agreed to carry out the Disaster Risk Reduction Management Projects in Ormoc City through the Japan Overseas Cooperation Volunteers (JOCV) Program which is one of the programs of JICA directed at providing technical assistance in developing countries in principle;

WHEREAS, the MOA stipulates the specific obligations and agreements of the parties towards the implementation of said Program, under the terms and conditions therein set forth and shall cover a period of Twenty Four (24) months commencing on March, 2014;

WHEREAS, this august Body believes that the agreement is advantageous to the City of Ormoc hence, deserving of its most favorable action;

WHEREFORE, on motion of SP Member Vincent L. Rama, Chairman, Committee on Environment and Natural Resources, jointly seconded by SP Members Pedro Godiardo P. Ebcas and Mariano Y. Corro; be it
