## RESOLUTION NO. 2014-037

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE CITY GOVERNMENT OF ORMOC AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), REPRESENTED BY ITS SECRETARY HON. MAR ROXAS, FOR THE RECONSTRUCTION ASSISTANCE FOR YOLANDA (RAY) AFFECTED AREAS.

WHEREAS, this Sanggunian received an Urgent Indorsement dated February 19, 2014 from the Office of the City Mayor relative to the Memorandum of Agreement (MOA) to be entered into by and between the Department of the Interior and Local Government (DILG), represented by its Secretary Hon. Mar Roxas, and the Local Government Unit of Ormoc City, and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, the Memorandum of Agreement deals with the Reconstruction Assistance for Yolanda (RAY) affected areas and will serve as basis for the release of funds from the National Government that will be utilized for the rehabilitation and reconstruction of damaged LGU infrastructures and facilities as implied in the communication of Ms. Lucia C. Ong, OIC – City Director, DILG dated February 19, 2014;

WHEREAS, the DILG as a government agency with the authority to supervise throughout local governments, is responsible for: (i) building technical and financial capacities to ensure that LGUs demonstrate excellence in local governance as the latter provide quality services, nurtures, protects and empowers constituents, and (ii) extending assistance to LGUs as may be necessary, to address DRR/CCA issues covering preparedness, response and relief, and rehabilitation and recovery;

WHEREAS, LGU-Ormoc assumes the primary responsibility for the provision of basic services and facilities and the improvement of the quality of life of their constituents as specifically provided under the Local Government Code of 1991 or Republic Act no. 7160;

WHEREAS, considering the typhoon-affected communities in the City of Ormoc, the concerned parties acknowledge that there is a need for the immediate rehabilitation and reconstruction of damaged critical infrastructure and facilities that will restore local governance and economic activities;

WHEREAS, the MOA stipulates the specific obligations, covenants, and agreements of the parties towards the achievement of the Reconstruction Assistance for Yolanda affected areas, under the terms and conditions therein set forth;

WHEREFORE, on motion of SP Member Rolando M. Villasencio, Chairman, Committee on Infrastructure Development, jointly seconded by SP Members Antonio M. Codilla and Tomas R. Serafica; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THE CITY GOVERNMENT OF ORMOC AND THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), REPRESENTED BY ITS SECRETARY HON. MAR ROXAS, FOR THE RECONSTRUCTION ASSISTANCE FOR YOLANDA (RAY) AFFECTED AREAS.
