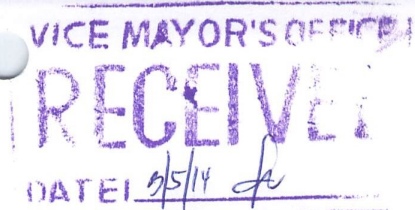

MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF
OF THE CITY GOVERNMENT OF ORMOC WITH THE
DEPARTMENT OF HEALTH - REGIONAL OFFICE NO. 8 (DOH-
RO8), REPRESENTED BY JOSE R. LLACUNA, JR., COVERING
THE IMMEDIATE RECONSTRUCTION AND REHABILITATION
OF THE THREE (3) IDENTIFIED DISTRICT HEALTH CENTERS
IN ORMOC CITY, TO WIT:

1. LINAO DISTRICT HEALTH CENTER -	P 150,000.00
2. CURVA DISTRICT HEALTH CENTER -	P 200,000.00
3. VALENCIA DISTRICT HEALTH CENTER -	P 150,000.00

WHEREAS, this august Body received an urgent Indorsement dated February 26, 2014 from the Office of the City Mayor relative to the Memorandum of Agreement (MOA) to be entered into by and between the Department of Health - Regional Office No.8 (DOH-RO8), represented by Jose R. Llacuna, Jr., MD, MPH, CESO IV in his capacity as Director IV and the City Government of Ormoc, for the implementation of the immediate Repair of Health Facilities affected by the Super Typhoon Disaster;

WHEREAS, the DOH issued Department Order No.2014-0011 dated January 28, 2013 re: "Guidelines for the Release and Utilization of the Special Allotment Release Order No. B-13-01354", which objective is to provide capital outlay for immediate re-construction and repair/rehabilitation of health facilities affected by the Typhoon Yolanda Disaster and make them functional to attend to the needs of the affected population especially the poorest family;

WHEREAS the DOH-RFO8 has presented the rapid assessment findings of damaged health facilities by the super Typhoon Yolanda in Eastern Visayas during the Health Facilities Enhancement Program (HFEP) Regional Summit Workshop last February 13 to 14, 2014 with the objective of restoring the functionality of these health facilities through immediate repairs/quick fix;

WHEREAS, LGU Ormoc confirmed the said rapid assessment findings with further information that it has identified the above-enumerated District Health Centers for immediate repair with the corresponding funding requirements to be funded by the Department of Health in the total amount of FIVE HUNDRED THOUSAND PESOS (Php500,000.00);

WHEREAS, the concerned parties mutually agreed to collaborate for the rehabilitation of the aforementioned District Health Centers in Ormoc City, subject to the specific obligations and agreement towards the achievement of the rehabilitation, as stipulated therein;

WHEREFORE, on motion of Honorable SP Member Mario M. Rodriguez, Chairman, Committee on Health & Sanitation, severally seconded by Honorable SP Members Mariano Y. Corro, Pedro Godiardo P. Ebcas, Tomas R. Serafica and Eusebio Gerardo S. Penserga; be it


RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to this Sanggunian for its information and files;
