RESOLUTION NO. 2014-047

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE ORMOC CITY MAYOR EDWARD C. CODILLA TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, ROTARY INTERNATIONAL DISTRICT 3780, REPRESENTED BY ITS DISTRICT GOVERNOR, MR. FRANCIS RIVERA, THE ROTARY CLUB OF ORMOC, R.I. DISTRICT 3860 ("RC ORMOC), REPRESENTED BY THE PRESIDENT, MR. BUMAGAT, ANDTHE ORMOC FISH WARDEN ASSOCIATION, THE *FOR* **PURPOSE** OF CREATING SUSTAINABLE LIVELIHOOD FOR THE SUPER TYPHOON YOLANDA-AFFECTED FISHER FOLKS OF ORMOC CITY.

WHEREAS, an Urgent Indorsement was received by this Sanggunian dated March 13, 2014 from the Office of the City Mayor relative to the Memorandum of Agreement (the "MOA") to be entered into by and among the Rotary International District 3780 (the "District"), represented by its District Governor, Mr. Francis A Rivera, the Rotary Club of Ormoc, R.I. District 3860 (the "RC Ormoc"), represented by the President, Mr. Troy Bumagat, the Local Government Unit of Ormoc (the "LGU Ormoc"), and the Ormoc Fish Warden Association (the "Association"), and further requesting that the Honorable City Mayor be granted the authority to sign the said MOA, for and in behalf of the City Government of Ormoc, for the purpose of creating a sustainable livelihood for the Super Typhoon Yolanda-affected fisher folks of Ormoc City.

WHEREAS, the livelihood project covered by the MOA involves the provision of motorized fishing boats, fish nets, and other fishing paraphernalia to the Super Typhoon Yolanda displaced and adversely-affected fisher folks duly registered with the City Agriculture Office;

WHEREAS, the District and the RC Ormoc are civic organizations of business, professional and community leaders united worldwide to provide humanitarian service, encourage high ethical standards in all vocations and help build goodwill and peace in the world;

WHEREAS, under its Rotary Care Program, the District has manifested their willingness to provide the funds necessary to finance the Project, and shall implement distribution and use thereof through the RC Ormoc;

WHEREAS, the Ormoc Fish Warden Association is a non-profit and non-stock association of fisher folks in Ormoc City, duly organized and existing under Philippine laws, who are engaged in small-scale fishing activities within its internal waters, subject to the rights, privileges and responsibilities provided under Republic Act. No 8550, otherwise known as the Philippine Fisheries Code of 1998 and, which livelihood was destroyed by Super Typhoon Yolanda;

WHEREAS, the LGU Ormoc, with all the powers inherent as provided for under Republic Act No. 7160, otherwise known as the Local Government Code of 1991, has agreed to monitor compliance by the Association of the terms and conditions for the implementation of the livelihood project as provided in the MOA;

WHEREAS, this Sanggunian, upon its thorough review and consideration, finds the MOA to be in order and beneficial to the Super Typhoon Yolanda-affected fisher folks in Ormoc City, and hence, quite deserving and worthy of its approval;

WHEREFORE, on motion of Honorable SP Member Benjamin S. Pongos Jr., Vice-Chairman, Committee on Agriculture, jointly seconded by Honorable SP Members Mario M. Rodriguez and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE ORMOC CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA), FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, WITH THE ROTARY INTERNATIONAL DISTRICT 3780, REPRESENTED BY ITS DISTRICT GOVERNOR, MR. FRANCIS A RIVERA, THE ROTARY CLUB OF ORMOC, R.I. DISTRICT 3860 ("RC ORMOC), REPRESENTED BY THE PRESIDENT, MR. TROY BUMAGAT, AND THE ORMOC FISH WARDEN ASSOCIATION, FOR THE PURPOSE OF CREATING A SUSTAINABLE LIVELIHOOD FOR THE SUPER TYPHOON YOLANDA-AFFECTED FISHER FOLKS OF ORMOC CITY.
