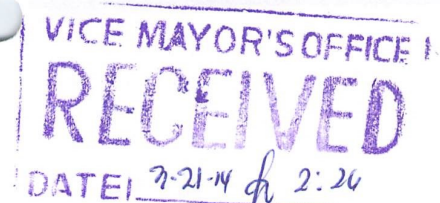


ADOPTED, March 20, 2014.
