CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, WITH WORLD VISION DEVELOPMENT FOUNDATION, INC. REPRESENTED BY ITS NATIONAL DIRECTOR JOSAIAS DELA CRUZ, FOR A STRATEGIC PARTNERSHIP AS ONE OF THE KEY TO EFFECTIVELY IMPLEMENT AND SUSTAIN DEVELOPMENT INTERVENTION IN ORMOC CITY.

WHEREAS, this august Body received an Urgent Indorsement dated March 19, 2014 from the Office of the City Mayor relative to the Memorandum of Agreement (MOA) to be entered into by the World Vision Development Foundation, Inc., represented by its National Director Josaias Dela Cruz and the City Government of Ormoc and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc.

WHEREAS, World Vision Development Foundation, Inc. is a global Christian, relief, development and advocacy organization dedicated to protect the survival and meet the immediate needs of families affected by Typhoon Yolanda, and to strengthen the resilience and self recovery of typhoon affected communities and children;

WHEREAS, World Vision is aiming to reach out to at least 1,964 households in Ormoc City through an integrated, multi-sector approach to support household and community-level needs in shelter, water, sanitation and hygiene (WASH), livelihoods, education, health and nutrition and other community infrastructure;

WHEREAS, the aforementioned foundation has selected its priority areas through analysis of the extent and intensity of the damage, pre typhoon poverty incidence, the presence of other humanitarian actors, and world vision's existing presence. Furthermore, they selected its target beneficiaries through consultation with communities, field validation of most affected families, and partnership with local authorities, other NGOs and local partners using agreed selection criteria to ensure a coordinated and equitable approach;

WHEREAS, the World Vision is committed to provide support to the effort of the Local Government Unit of Ormoc to be self-reliant and being able to discharge functions and responsibilities necessary, appropriate or incidental to efficient and effective provision of the basic services and facilities to their respective constituents as well as to work and strengthen their capacity in disaster management, governance, and development planning;

WHEREAS, LGU-Ormoc acknowledges and affirms the noble intention of World Vision to assist the Yolanda-affected communities in Ormoc City in its recovery and development;

WHEREAS, the said Agreement stipulates the specific obligations of the concerned parties towards the achievement of the program implementation, and this Sanggunian, upon thorough review of the MOA, finds that it is indeed beneficial, therefore deserving of affirmative action;
