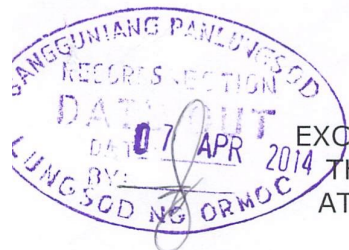

RESOLUTION NO. 2014-055

A RESOLUTION AUTHORIZING ORMOC CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REPRESENTED BY ITS REGIONAL DIRECTOR, NEMIA T. TAPISPISAN FOR THE IMPLEMENTATION OF THE CASH FOR WORK REBUILDING COMMUNITY LIVELIHOOD ASSETS AFFECTED BY SUPER TYPHOON YOLANDA.

WHEREAS, the damages brought on by typhoon Yolanda were so extensive and the magnitude of disruption to the means of livelihood, commercial establishments, offices, telecommunication, infrastructure and even the normal ways of life of people are among the problems that prompted the Ormoc City Government and the National Government to declare a state of calamity to mobilize resources and hasten the efforts for rehabilitation,

WHEREAS, as provided for under RA 7160, also known as Local Government Code of the Philippines, the Local Government is mandated to undertake the functions of providing immediate basic relief assistance to the affected families such as food, clothing, shelter, emotional support as well as rehabilitation needs;

WHEREAS, the Department of Social Welfare and Development is directed to provide social welfare and development programs particularly through technical assistance and resource augmentation to continuously help alleviate poverty and ensure the welfare of the disadvantaged and vulnerable groups;

WHEREAS, the DSWD through Sustainable Livelihood Program will be implementing a Cash for Work for Re Building Community Livelihood Assets Affected by Super typhoon Yolanda to provide emergency employment, immediate income and to support the re building of damaged livelihood assets of the affected marginalized sector;

WHEREAS, this Cash for Work (CFW) program is a strategy identified in helping Typhoon Yolanda survivors where the victims are directly involved in community endeavors and their contributions to rehabilitation efforts will be maximized;

WHEREFORE, on motion of Honorable SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family, severally seconded by Honorable SP Members Mariano Y. Corro, Pedro Godiardo P. Ebcas and Tomas R. Serafica;

BE IT RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING ORMOC CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REPRESENTED BY ITS REGIONAL DIRECTOR, NEMIA T. TAPISPISAN FOR THE EMPLOYMENT OF THE CASH FOR WORK REBUILDING COMMUNITY LIVELIHOOD ASSETS AFFECTED BY SUPER TYPHOON YOLANDA;
