A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST THE CURRENT APPROPRIATION - UNDER THE ACCOUNT INCENTIVES 4411-101-749(14) -AMOUNT OF FORTY ONE THOUSAND PESOS (P41,000.00) FOR THE PAYMENT OF CY 2013 UNPAID OBLIGATION OF THE CITY HEALTH OFFICE SPECIFICALLY FOR THE PAYROLL OF ITS EMPLOYEES WHO CONDUCTED DELIVERIES AND POST PARTUM CARE SERVICES AFTER THE TYPHOON YOLANDA.

WHEREAS, an urgent Indorsement was received by this Sanggunian dated April 1 2014, from the Office of the City Mayor relative to the request of Dr. Nelita D. Navales, City Health Officer II, for the obligation and payment of the payroll of the CHO employees for Deliveries and Post Partum Care Services conducted after Typhoon Yolanda to be charged to current account - Incentives 4411-101-749(14) in the amount of Forty One Thousand Pesos Only (P41,000.00);

WHEREAS, considering that the City Accounting Office has already closed the Books of Accounts for CY 2013, such unpaid obligation cannot be settled without the necessary resolution effecting and charging its payment to the current appropriation in as much as the expenditure is still part of the Year 2013;

WHEREAS, the City Budget Officer, through an Indorsement dated April 8, 2014 stated that the requested amount of Forty One Thousand Pesos (P41,000.00) to cover the payment of said CHO payroll may be charged against the current appropriation under the account - Incentives 4411-101-749(14) - of the City Health Office;
