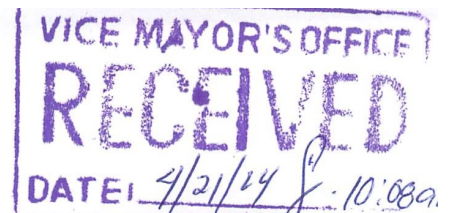

RESOLUTION NO. 2014-066

*A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, WITH THE INITIATIVE FOR DIALOGUE AND EMPOWERMENT THROUGH ALTERNATIVE LEGAL SERVICE, INC. (IDEALS), REPRESENTED BY ITS EXECUTIVE DIRECTOR EDGARDO LIGON AND THE PHILIPPINE STATISTICS AUTHORITY-NATIONAL STATISTICS OFFICE (PSA-NSO), REPRESENTED BY LINA V. CASTRO, THE UNITED NATIONS HIGH COMMISSIONER FOR REFUGEES (UNHCR), REPRESENTED BY KESHAB SHRESTHA, AND THE LOCAL CIVIL REGISTRY (LCR), REPRESENTED BY ARCHILLES A. SILVA, FOR THE IMPLEMENTATION OF THE UNHCR PROJECT TITLED MOBILE CIVIL REGISTRATION AT TYPHOON YOLANDA AFFECTED AREAS.*

WHEREAS, this august Body received an Urgent Indorsement dated April 3, 2014 from the Office of the City Mayor relative to the Memorandum of Agreement (MOA) to be entered into by the Initiative for Dialogue and Empowerment through alternative Legal Services, Inc. (IDEALS, Inc.), represented by its Executive Dir. Edgardo Ligon, and the Philippine Statistics Authority-National Statistics Office (PSA-NSO), represented by Lina V. Castro, and the United Nations High Commissioner for Refugees (UNHCR), represented by Keshab Shrestha, the City Government of Ormoc, and the Local Civil Registry (LCR), represented by Archilles A. Silva, and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;



WHEREAS, IDEALS Inc., is a non-government organization, established to address the legal and technical needs of marginalized, disempowered and vulnerable groups, particularly the agrarian reform beneficiaries, farmer-traders and migrants sector of society;

WHEREAS, one of the activities that the IDEALS Inc. is currently undertaking is the conduct of legal mission to the victims and survivors of Super Typhoon Yolanda which includes, among others, the retrieval and/or application for lost Identification Documents, certificates or proof of living/death, titles of land, scholastic records and other important legal documents;

WHEREAS, PSA-NSO is a government statistical agency responsible in collecting, compiling, classifying, producing, publishing, and disseminating general-purpose statistics;

WHEREAS, UNHCR is an agency of the United Nations mandated to lead and co-ordinate international action to protect refugees and resolve refugee problems world wide;

WHEREAS, IDEALS Inc. is the implementing partner of UNHCR for the project titled Mobile Civil Registration at Haiyan affected areas covering 20 municipalities/cities with target beneficiaries of 80,000 individuals until 30<sup>th</sup> of June 2014;

WHEREAS, there is a need to coordinate and collaborate with different agencies and organizations which include the NSO, UNHCR, the Municipalities/cities of the covered affected areas and their respective Local Registry offices, to fully and effectively execute the aforesaid legal mission;

WHEREAS, the said Agreement stipulates the specific obligations of the concerned parties towards the achievement of the project implementation, and this Sanggunian, upon thorough review of the MOA, finds that it is indeed beneficial to the City of Ormoc and, therefore, deserving of its wholehearted support and thereby, of its affirmative action;

WHEREFORE, on motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Vincent L. Rama, Mariano Y. Corro, Pedro Godiardo P. Ebcas and Tomas R. Serafica; be it
