A RESOLUTION APPROVING THE REPLACEMENT OF THE OPEN HIGH SCHOOL, AS LISTED IN THE APPROVED ANTI-POVERTY REDUCTION PROJECTS FOR CY 2014 WITH REPAIR OF THE ALTERNATIVE LEARNING SYSTEM FACILITIES AS PER LOCAL POVERTY REDUCTION ACTION TEAM (LPRAT) RESOLUTION NO. 2014-01 DATED APRIL 21, 2014.

WHEREAS, in CY 2013 the Local Poverty Reduction Action Team (LPRAT) of Ormoc City has submitted to the Regional Poverty Reduction Action Team (RPRAT) the list of 2014 anti-poverty reduction projects for inclusion in the 2014 National budget thru the so called Bottom-up Budgeting (BuB);

WHEREAS, said list of priority projects was duly endorsed by the partner Civil Society Organization (CSO) representatives as proof of genuine participation in identifying the priority projects;

WHEREAS, the Open High School Project was among the List of Priority Poverty Projects for 2014 but recently this project was identified as ineligible by the Department of Education (DepEd) and should be considered for replacement;

WHEREAS, in consultation with representatives from DepEd and the members of the LPRAT, it has been approved that the replacement for the Open High School project is the Repair of the Alternative Learning System (ALS) Facilities through the Local Poverty Reduction Action Team Resolution No. 1 Series 2014;

WHEREAS, a Sangguniang Panlungsod Resolution is necessary to approve the replacement of the Open High School with Repair of Alternative Learning System (ALS) Facilities as required in the DBM NBM No. 121 dated March 18, 2014;

WHEREFORE, on motion of Honorable SP Member Vincent L. Rama, Chairman Committee on Social Welfare, Senior Citizens, Women & Family, jointly seconded by Honorable SP Members Pedro Godiardo P. Ebcas and Eusebio Gerardo S. Penserga; be it
