RESOLUTION NO. 2014-078

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH SAVE THE CHILDREN INTERNATIONAL, REPRESENTED BY ITS FIELD MANAGER, THOMAS HOWELLS, FOR THE REPAIR AND REHABILITATION OF COVERED COURTS LOCATED AT BARANGAY CAN-ADIENG AND BARANGAY BAGONG BUHAY, ORMOC CITY.

WHEREAS, an Urgent Indorsement was received by this Sanggunian dated April 10, 2014 from the Office of the City Mayor relative to the Memorandum of Agreement (MOA) to be entered into by the City Government of Ormoc with Save the Children International, represented by its Field Manager, Thomas Howells for the repair and rehabilitation of Covered Courts located at Barangay Can-adieng and Barangay Bagong Buhay, Ormoc City and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, Save the Children International is an international non-government organization working in partnership with governments, foundations, corporations, national and international agencies to uphold children's rights;

WHEREAS, numerous educational sporting facilities in Ormoc City were seriously damaged by the onslaught of Typhoon Yolanda and became totally non-functional or partially functional thereby depriving the population of access to quality educational sporting services, among those damaged facilities were the covered courts of Brgy. Can-adieng and Brgy. Bagong Buhay;

WHEREAS, Save the Children International wishes to provide support to the Yolanda-affected communities in Ormoc specifically in the repair/rehabilitation/construction of damaged facilities, in line with its commitment to make lasting changes in children's lives by implementing programs geared towards relief and emergency response;

WHEREAS, LGU-Ormoc commits to provide all the necessary non-monetary assistance and support to ensure the smooth and speedy implementation of the repair and rehabilitation of the aforementioned covered courts;

WHEREAS, said agreement stipulates the specific obligations of the concerned parties, and this Sanggunian, upon thorough review of the MOA, finds that it is indeed beneficial to the general public, therefore deserving of affirmative action;

WHEREFORE, on motion of Honorable SP Member Mariano Y. Corro, Vice-Chairman, Committee on Laws and Ordinances, jointly seconded by Honorable SP Members Tomas R. Serafica and Pedro Godiardo P. Ebcas; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH SAVE THE CHILDREN INTERNATIONAL, REPRESENTED BY ITS FIELD MANAGER, THOMAS HOWELLS, FOR THE REPAIR AND REHABILITATION OF COVERED COURTS LOCATED AT BARANGAY CAN-ADIENG AND BARANGAY BAGONG BUHAY, ORMOC CITY;


ADOPTED, April 29, 2014.
