

RESOLUTION NO. 2014-079

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE HELP – Hilfe zur Selbsthilfe e.V., REPRESENTED BY ITS HEAD OF MISSION, HENNING HILLMER, FOR THE IMPLEMENTATION OF THE HELP PROJECT TITLED REHABILITATION AND DEVELOPMENT OF THE FRESH WATER FISH HATCHERY AT BARANGAY MACABUG, ORMOC CITY, WITH A PROJECT COST AMOUNTING TO ONE MILLION EIGHT HUNDRED THOUSAND PESOS (PHP 1,800,000.00).

WHEREAS, an Urgent Indorsement was received by this Sanggunian dated April 10, 2014 from the Office of the City Mayor regarding the Memorandum of Understanding to be entered into by and between the HELP – Hilfe zur Selbsthilfe e.V., represented by its Head of Mission, Henning Hillmer, and the City Government of Ormoc, and further requesting that the Honorable City Mayor be granted the authority to sign the aforesaid understanding for and in behalf of the City Government of Ormoc;

WHEREAS, HELP is a humanitarian and non-governmental organization, independent of any private, financial or commercial interest which action should be guided only by requests from the population, by identified needs and by the ability, willingness and potential that exist locally to respond the needs;

WHEREAS, said MOU has a project objective to rehabilitate and develop the Fresh Water Fish Hatchery at Barangay Macabug, Ormoc City, that was damaged by Typhoon Yolanda in order to sustain the needs of the fishfarmers to avail good quality tilapia fingerlings to culture for livelihood;

WHEREAS, as provided in the MOU, the rehabilitation shall be done by HELP at no further cost or counterpart from the LGU;

WHEREAS, LGU-Ormoc recognizes and affirms the impressive intention of HELP to support the Yolanda-affected fishfarmers in Ormoc City in its recovery and development;

WHEREAS, both parties mutually agreed to collaborate and coordinate for the rehabilitation and development of the fresh water fish hatchery at Barangay Macabug, Ormoc City, subject to the specific obligations of the concerned parties towards the achievement of the implementation of the project, as stipulated therein;

WHEREFORE, on motion of Honorable SP Member Mariano Y. Corro, Vice-Chairman, Committee on Laws & Ordinances, jointly seconded by Honorable SP Members Vincent L. Rama and Tomas R. Serafica; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE HELP – Hilfe zur Selbsthilfe e.V., REPRESENTED BY ITS HEAD OF MISSION, HENNING HILLMER, FOR THE IMPLEMENTATION OF THE HELP PROJECT TITLED REHABILITATION AND DEVELOPMENT OF THE FRESH WATER FISH HATCHERY AT BARANGAY MACABUG, ORMOC CITY, WITH A PROJECT COST AMOUNTING TO ONE MILLION EIGHT HUNDRED THOUSAND PESOS (PHP 1,800,000.00);


ADOPTED, April 29, 2014.
