12, 2014, AT SAME TIME.*

WHEREAS, the Internal Rules and Regulations of the Thirteenth Sangguniang Panlungsod ng Ormoc provides that its Regular Session shall be on Thursday of every week at 2:00 o'clock in the afternoon;
