A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE AGAINST THE CURRENT APPROPRIATION-PROVISION FOR PRIOR YEAR'S OBLIGATION – A NON-OFFICE ACCOUNT OF THE CITY'S ANNUAL BUDGET FOR CY 2014, THE AMOUNT OF TWO HUNDRED SEVENTY SEVEN THOUSAND TWO HUNDRED NINETY NINE PESOS & 41/100 (P277 299.41) ONLY AS PAYMENT OF PRIOR YEAR'S OBLIGATION OF THE HUMAN RESOURCE MANAGEMENT OFFICE (HRMO).

WHEREAS, an indorsement was received by this Sanggunian dated May 8, 2014, from the Office of the Honorable City Mayor Edward C. Codilla, relative to the request of Mrs. Adelaida H. Biacolo, Human Resource Management Officer, for the Payment of Prior Year's Obligation specifically for the unpaid salaries/benefits of their office in the amount of Two Hundred Seventy Seven Thousand Two Hundred Ninety Nine Pesos & 41/100 (P277,299.41);

WHEREAS, Mrs. Adelaida H. Biacolo submitted a computation of the total appropriation required for the payment of salaries & benefits of some employees of the City Government as of December 31, 2013 reflecting therein the names of the claimant, the corresponding amount due to them and justification as to why they were not able to receive their salaries and other benefits;

WHEREAS, the aforementioned obligation was left unpaid due to the failure of the concerned employees to submit on time the necessary documents in support to their claims until the closing of the Books of Accounts at the End of Year 2013. In this regard, a Sangguniang Panlungsod resolution is necessary to appropriately charge its payment to the current appropriation;
