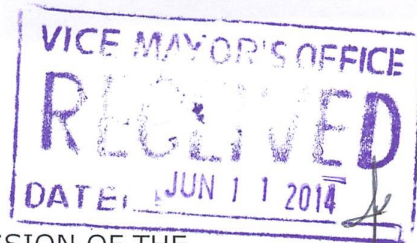

RESOLUTION NO. 2014-100

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ACCEPT AND SIGN THE DEED OF DONATION MADE AND EXECUTED BY THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP), REPRESENTED BY ITS HEAD OF BRANCH BANKING SECTOR (BBS), EVP ANTHONY T. ROBLES, AS DONOR OF A CASH DONATION IN THE AMOUNT OF ONE HUNDRED THOUSAND PHILIPPINE PESOS (PHP 100,000.00) IN FAVOR OF LOCAL GOVERNMENT UNIT (LGU) ORMOC AS DONEE IN AID OF THE EVACUEES BROUGHT ABOUT BY SUPER TYPHOON YOLANDA.

WHEREAS, an Urgent Indorsement was received by this Sanggunian dated May 29, 2014 from the Office of the City Mayor relative to the Deed of Donation of the Development Bank of the Philippines (DBP), represented by its Head of Branch Banking Sector (BBS), EVP Anthony T. Robles, as DONOR, in favor of the Local Government Unit of Ormoc City, represented by Hon. Edward C. Codilla, as DONEE, requesting that the Honorable City Mayor be granted the authority to sign the said Deed of Donation for and in behalf of Local Government Unit (LGU) Ormoc, for the benefit of its constituents who have been evacuees caused by the recent Super Typhoon Yolanda, a photocopy of the final Deed of Donation of which is hereto attached and made an integral part hereof;

WHEREAS, in line with the Donor's corporate social responsibility of sharing the benefits of its financial achievements to the disadvantaged sectors of society, DBP desires to help and give aid to LGU Ormoc for the benefit of its constituents who have been evacuees caused by the recent Super Typhoon Yolanda by way of a cash donation in the amount of ONE HUNDRED THOUSAND PHILIPPINE PESOS (PHP100,000.00);

WHEREAS, as provided for in the Deed of Donation, the DONOR donates to the DONEE, and the DONEE accepts the DONATED AMOUNT, with full understanding that the use is subject to the usual accounting and auditing procedures;

WHEREAS, upon execution of the DEED of DONATION, the DONOR shall give the DONEE a check equal to the DONATED AMOUNT. Immediately thereafter, the DONEE shall issue an Official Receipt to the DONOR, and the DONEE shall deposit the check to the bank account of LGU Ormoc with the DBP Ormoc Branch;

WHEREAS, the DONOR stipulates and the DONEE agrees that the DONATED AMOUNT shall be used exclusively for the relocation and house construction projects/programs of the said evacuees and upon utilization, the DONEE shall provide the DONOR a Post-Activity Report manifesting that the objective of the DONATION has been achieved, and a Report of Disbursement;

WHEREAS, this Sanggunian believes that the Donation made by the DONOR is of great help to the victims of the Super Typhoon Yolanda, and is in fact most appreciative of such generous and magnanimous act by the DONOR, and hence, signifies its approval and imprimatur of the same by granting authority to the Honorable City Mayor to sign the same for and in behalf of LGU Ormoc;

WHEREFORE, foregoing premises considered, on motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Vincent L. Rama, Antonio M. Codilla and Mario M. Rodriguez; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ACCEPT AND SIGN THE DEED OF DONATION MADE AND EXECUTED BY THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP), REPRESENTED BY ITS HEAD OF BRANCH BANKING SECTOR (BBS), EVP ANTHONY T. Codilla; the City Administrator; the City Legal Officer, the City Accountant, the City Treasurer, the City Auditor, the Development Bank of the Philippines, the DILG-Director, Ms. Lucia C. Ong and other offices concerned;
