RESOLUTION NO. 2014-102

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF LOCAL GOVERNMENT UNIT (LGU) ORMOC WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), THRU ITS REGIONAL DIRECTOR FOR REGION EIGHT, PEDRO A. NOVAL, JR., FOR THE RELEASE AND UTILIZATION OF THE PERFORMANCE CHALLENGE FUND (PCF).

WHEREAS, this Sanggunian received an Indorsement dated May 28, 2014 from the Office of the Honorable City Mayor Edward C. Codilla relative to the Memorandum of Agreement (MOA) to be entered into by the Department of the Interior and Local Government (DILG) and the Local Government Unit of Ormoc, and further requesting that the Honorable City Mayor be granted the authority to sign the said MOA for and in behalf of LGUOrmoc, a photocopy of the final MOA of which is hereto attached and made an integral part hereof;

WHEREAS, the Performance Challenge Fund (PCF) is administered by the DILG in collaboration with the Department of Budget and Management (DBM), to recognize good governance performance particularly in the adoption of "scaled-up Good Housekeeping" along the governance areas of development planning, sound financial management, transparency and accountability, valuing performance monitoring and the frontline service performance;



WHEREAS, the PCF for LGUs is a flagship program of the DILG that serves as a facility that will help stimulate LGUs that put premium on transparency and accountability to enable them to avail themselves of financial support to jumpstart and sustain local socio-economic development initiatives supportive of national goals and priorities, and is an incentive fund to eligible LGUs to support the implementation of hi-impact capital investment projects in the Annual Investment Program (AIP);

WHEREAS, the Local Government Unit of Ormoc City was awarded the Seal of Good Housekeeping (SGH) in 2012, and entitled to receive the PCF Subsidy in the amount of THREE MILLION PHILIPPINE PESOS (PHP3,000,000.00) which may be utilized for qualified projects, among which but not limited to, Tourism, DRRM Act of 2010, and Ecological Waste Management Act of 2000, and in this particular instance, a project for the construction and rehabilitation of the infrastructure for the water supply system for identified various barangays in LGU Ormoc;

WHEREAS, the eligible projects of the PCF subsidy are those that support the national priorities of the present administration in achieving the Millennium Development Goals (MDGs) such as preparedness to disasters and adaptation to climate change, sustainable environmental management, transparent & accountable local governance;

WHEREAS, the MOA stipulates the specific obligations and covenants of the concerned parties towards the achievement of the implementation of said project, under the terms and conditions therein set forth, in order to fund the project as identified and detailed out in an approved Project Proposal and Program of Works hereto attached as Annexes 'A' and 'B', respectively, and made integral parts hereof;

WHEREFORE, on motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Eusebio Gerardo S. Penserga, Pedro Godiardo P. Ebcas, Vincent L. Rama, Antonio M. Codilla, Ruben R. Capahi, Mario M. Rodriguez and Rolando M. Villasencio; be it
