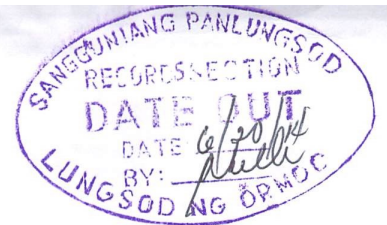

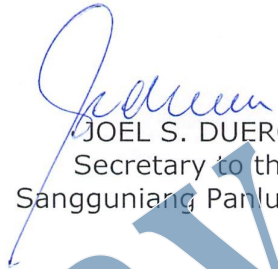
ADOPTED, June 19, 2014.
