- A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE TWO (2) MEMORANDUM OF AGREEMENTS (MOAS) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ORMOS (LGU-ORMOS), WITH THE FOLLOWING: THE SECURITY BANK FOUNDATION INC. (SBFI), REPRESENTED CHAIRMAN, MR. RAFAEL F. SIMPAO JR.; THE ATENEO DE MANILA UNIVERSITY (ADMU), REPRESENTED BY ITS PRESIDENT, REV. FR. JOSE RAMON T. VILLARIN, SJ; AND THE DEPARTMENT OF EDUCATION-DIVISION ORMOO CITY, REPRESENTED BY ITS SUPERINTENDENT, MS. MARIZA S. MAGAN, FOR THE IMPLEMENTATION OF THE FOLLOWING PROJECTS TO BE FUNDED BY THE SBFI, TO WIT:
 - 1) CONSTRUCTION OF SIX (6) CLASSROOMS AT IPIL CENTRAL SCHOOL, BARANGAY IPIL, ORMOC CITY.
 - 2) CONSTRUCTION OF SIX (6) CLASSROOMS AT NEW ORMOC CITY NATIONAL HIGH SCHOOL, ORMOC CITY.

WHEREAS, an Indorsement dated April 22, 2014 was received by this Sanggunian from the Office of the City Mayor relative to a Memorandum of Agreement(MOA) to be entered into by LGU-Ormoc with the following: Security Bank Foundation Inc. (SBFI), Ateneo de Manila University (AdMU), Department of Education and the City Government of Ormoc (LGU), for the construction of classrooms, and further requesting that the Honorable City Mayor be granted the authority to sign the said MOA for and in behalf of LGU-Ormoc, a photocopy of the MOA of which is hereto attached and made an integral part hereof;

WHEREAS, the SBFI and AdMU entered into a separate Memorandum of Agreement for the construction of Sixty (60) classrooms herein referred to as the "Project", in communities or areas to be jointly determined by both parties, with an estimated aggregate total project cost of Ph P31,300,000.00 over a period of five (5) years;

WHEREAS, SBFI has chosen IPIL CENTRAL SCHOOL and NEW ORMOC CITY NATIONAL HIGH SCHOOL, both in this City, to be the beneficiaries of said Project to be funded by the SBFI, which objective is to construct Six (6) classrooms in each school, with a total floor area of 598.5 square meters, measuring 7m x 9m each classroom, for which purpose two (2) MOAs embodying separately the aforementioned classrooms to be built on each school shall be entered into by the aforementioned parties:

WHEREAS, the involvement of the LGU-Ormoc, which is referred in subject MOAs as 'Partner LGU', and the Department of Education Division Office is needed for the successful implementation of the Project in the aforementioned schools where the classrooms will be constructed, hence, the need for the concerned parties to enter into a MOA covering their obligations and responsibilities relative to said project, and other terms and conditions of said agreement;

WHEREAS, hence, the MOA stipulates the specific obligations and responsibilities of the concerned parties towards the achievement and implementation of the project, and this Sanggunian finds, after close and thorough review of the MOA, that the same is beneficial to the City, and therefore, most deserving of its utmost support and favorable consideration;

WHEREAS, this august Body respectfully suggests that before the signing of the final MOA Item No. 1.2 relating to funding should already be filled-up:
