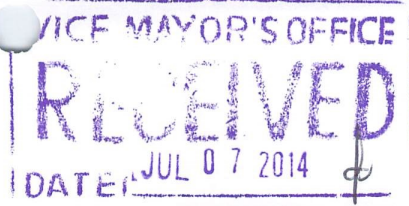

RESOLUTION NO. 2014-110

A RESOLUTION AUTHORIZING ORMOC CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE SAVE THE CHILDREN INTERNATIONAL, REPRESENTED BY ITS FIELD MANAGER, THOMAS HOWELLS FOR THE REPAIR/REHABILITATION OF ONE (1) DAY CARE CENTER SITUATED AT BARANGAY GREEN VALLEY, ORMOC CITY.

WHEREAS, an Indorsement was received by this Sangunian dated June 17, 2014 from the Office of the City Mayor relative to the Memorandum of Agreement (MOA) to be entered into by the City Government of Ormoc and Save the Children International, and further requesting that the Hon. City Mayor be granted the authority to sign the said MOA for and in behalf of the City Government of Ormoc, a photocopy of the final and revised MOA of which is hereto attached and made an integral part hereof;

WHEREAS, Super typhoon Yolanda (International codename: Haiyan) barreled through most of the Visayas, leaving a trail of devastation in its wake and damaged or destroyed more than 17,500 schools and 2,500 day care centers, along with vast quantities of school furniture and educational materials;

WHEREAS, in the immediate aftermath, Save the Children International, a non-governmental organization that promotes children's rights, provides relief and helps support children in developing countries, was instrumental in coordinating the education response effort and was active in a Back to Learning Campaign, which advocated for and supported children to return to school as soon as possible;

WHEREAS, Save the Children in line with its commitment to making lasting changes in children's lives by providing support to the government and affected communities, has chosen one Day Care Center situated at Barangay Green Valley, Ormoc City to be repaired/rehabilitated;

Serafica ; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING ORMOC CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE SAVE THE CHILDREN INTERNATIONAL, REPRESENTED BY ITS FIELD MANAGER, THOMAS HOWELLS FOR THE REPAIR/REHABILITATION OF ONE (1) DAY CARE CENTER SITUATED AT BARANGAY GREEN VALLEY, ORMOC CITY.
