A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC (LGU) WITH THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH), FOR THE IMPLEMENTATION OF THE PROJECT - PREVENTIVE MAINTENANCE (REVISED) OF BARANGAY PUNTA (PART OF WAR VETERAN AVENUE), ORMOC CITY, TO BE FUNDED BY THE CY 2013 SPECIAL LOCAL ROAD FUND (SLRF) UNDER R. A. 8794 OR THE MOTOR VEHICLE USERS CHARGE (MVUC) LAW.

WHEREAS, an Indorsement was received by this Sanggunian dated June 20, 2014 from the Office of the City Mayor Edward C. Codilla, relative to the Memorandum of Agreement (MOA) to be made and entered into by and between the Department of Public Works and Highways (DPWH) and the Local Government Unit of Ormoc City (LGU), for the implementation of the project Preventive Maintenance (Revised) of Brgy. Punta (Part of War Veteran Ave.), Ormoc City, to be funded under CY 2013 Special Local Road Fund (SLRF) in the amount of ONE MILLION NINE HUNDRED NINETY FOUR THOUSAND FIVE HUNDRED FORTY ONE PESOS & 03/100(P1,994,541.03) and further requesting that the Honorable City Mayor be granted the authority to sign the said agreement for and in behalf of the City Government of Ormoc;

WHEREAS, the MOA covers the release, utilization and liquidation of funds for the LGU eligible projects and activities such as road maintenance, road safety devices and traffic management funded by the Special Local Road Fund to be implemented by LGUs in accordance with the policies, standards and procedures of R. A. 8794 (MVUC Law) and its Implementing Rules & Regulations (IRR);

WHEREAS, said MOA provides for the implementation of an SLRF Project in the City of Ormoc particularly the Preventive Maintenance (Revised) of Brgy. Punta (Part of War Veteran Ave.), Ormoc City – with an appropriation of ONE MILLION NINE HUNDRED NINETY FOUR THOUSAND FIVE HUNDRED FORTY ONE PESOS & 03/100(P1,994,541.03) to be funded under the MVUC Special Local Road Fund, a photocopy of the final MOA of which is hereto attached and made an integral part hereof;

WHEREAS, this august Body finds the provisions of the MOA to be in order and deemed beneficial to the city, therefore deserving of affirmative action;


ADOPTED, July 03, 2014.
