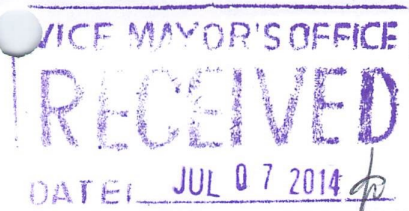


ADOPTED, July 03, 2014.
