## RESOLUTION NO. 2014-116

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE TWO (2) MEMORANDUM OF AGREEMENTS (MOAs) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC (LGU-ORMOC), WITH THE NATIONAL GRID CORPORATION OF ORMOC), WITH THE NATIONAL GRID CORPORATION OF THE PHILIPPINES (NGCP) THE SANGGUNIANG BARANGAY DOLORES, ORMOC CITY, DOLORES ELEMENTARY AND DOLORES NATIONAL HIGH SCHOOL, FOR CONSTRUCTION OF A ONE-STOREY CLASSROOM BUILDING EACH IN DOLORES ELEMENTARY SCHOOL AND DOLORES NATIONAL HIGH SCHOOL TO BE UNDERTAKEN AND FUNDED BY THE NGCP.

WHEREAS, an urgent Indorsements dated June 23, 2014 and July 3, 2014 were received by this Sanggunian from the Office of the City Mayor relative to the Memorandum of Agreements (MOAs) to be entered into by LGU-Ormoc with the National Grid Corporation of the Philippines (NGCP), the Sangguniang Barangay of Dolores, Ormoc City, Dolores Elementary School, and Dolores National High School, for the Construction of a one-storey three-classroom building each in Dolores Elem. School and Dolores National High School and further requesting that the Honorable City Mayor be granted the authority to sign the said MOAs for and in behalf of LGU-Ormoc, a photocopy of the final MOAs of which are hereto attached and made an integral part hereof;

WHEREAS, NGCP and LGU-Ormoc recognizes the vital role of the local community in nation building and are willing to promote community programs in partnership with local government units and other government agencies to contribute to the country's social and economic development;

WHEREAS, the Elementary and high school classrooms in Brgy. Dolores Ormoc City were among those heavily damaged educational buildings in the aftermath of Typhoon Yolanda;

WHEREAS, both Dolores Elementary School and Dolores National High School respectively requested NGCP for the Construction and Donation of a One Storey Three-Classroom Building, through GPTA Resolution No. 2014-01 of Dolores Elem. School and GPTA Resolution No. 5, Series 2014 of Dolores National High School, copies of which are hereto attached as Annex "A";

WHEREAS, the Brgy. Council of Dolores has passed and approved Resolution Nos. 2014-34 and 2014-35 requesting the NGCP for the construction of One Storey Three-Classroom Building in Dolores National High School and Dolores Elementary School respectively and Resolution Nos. 2014-40 and 2014-42 authorizing the Punong Barangay of Dolores together with Dolores Elementary and National High Schools to sign MOA in relation to the Construction and Donation of the aforementioned school buildings, copies of said resolutions are hereto attached as Annex" C";

WHEREAS, the requested school buildings shall be constructed by NGCP in a parcel of land, identified as Lot No.7324 declared under the name of the City of Ormoc, Leyte, as evidenced by Tax Declaration No. 00026-00082, copy of which is hereto attached as Annex "D". The specific site of each building is shown in the respective Site Development Plan submitted by both schools and marked as Annex "F" of this resolution;

WHEREAS, the LGU-Ormoc, Sangguniang Barangay of Dolores, Dolores Elementary School and Dolores National High School, as a token of gratitude to NGCP conveyed their willingness to help protect the NGCPs transmission facilities from bad elements or perpetrators of illegal acts;

WHEREAS, the MOA stipulates the specific obligations and covenants of the concerned parties towards the achievement of the projects, under the terms and conditions therein set forth, and this august Body having found the provisions of the agreement to be in order, resolves to give its full support to the projects;

WHEREFORE, on joint motion of Honorable SP Member Mario M. Rodriguez, Chairman, Committee on Education, Culture and the Arts, and Honorable SP Member Benjamin S. Pongos Ir., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Mariano Y. Corro, Pedro Godiardo P. Ebcas, Vincent L. Rama, Antonio M. Codilla and Tomas R. Serafica; be it

CODILLA TO ENTER INTO AND SIGN THE TWO (2) MEMORANDUM OF AGREEMENTS (MOAS) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC (LGU-ORMOC), WITH THE NATIONAL GRID CORPORATION OF THE PHILIPPINES (NGCP), THE SANGGUNIANG BARANGAY OF DOLORES, ORMOC CITY, DOLORES ELEMENTARY SCHOOL, AND DOLORES NATIONAL HIGH SCHOOL, FOR THE CONSTRUCTION OF A ONE-STOREY THREE-CLASSROOM BUILDING EACH IN DOLORES ELEMENTARY SCHOOL AND DOLORES NATIONAL HIGH SCHOOL TO BE UNDERTAKEN AND FUNDED BY THE NGCP.
