RESOLUTION NO. 2014-121

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO SIGN AND ACCEPT, FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC CITY (LGU-ORMOC), THE DEED OF DONATION MADE AND EXECUTED BY THE LOCAL GOVERNANCE SUPPORT PROGRAM FOR LOCAL ECONOMIC DEVELOPMENT (LGSP-LED), REPRESENTED BY AUSTERE A. PANADERO, DILG-UNDERSECRETARY AND CHAIRMAN OF LGSP-LED PROJECT STEERING COMMITTEE, AND FRANCISCO E. GENTORAL, PHILIPPINE PROGRAM DIRECTOR, THE DONOR, OF FIVE (5) UNITS 14-FT. TANDEM KAYAKS WITH TEN (10) PCS. PADDLES AND TEN (10) PCS. LIFEVESTS WORTH A TOTAL OF ONE HUNDRED THIRTY-EIGHT THOUSAND THREE HUNDRED NINETY-TWO AND 86/100 PHILIPPINE PESOS (PHP138,392.86) IN FAVOR OF THE LGU-ORMOC, THE DONEE.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc received an Indorsement dated July 8, 2014 from the Office of the City Mayor relative to the Deed of Donation of the Local Governance Support Program for Local Economic Development (LGSP-LED), represented by Austere A. Panadero, DILG-Undersecretary and Chairman of the LGSP-LED Project Steering Committee, and Francisco E. Gentoral, Philippine Program Director, as DONOR, in favor of the Local Government Unit of Ormoc City, represented by Hon. Edward C. Codilla, as DONEE, of Five (5) Units 14 ft. Kayaks with Ten (10) pcs. Paddles and Ten (10) pcs. Lifevests with a total worth of ONE HUNDRED THIRTY-EIGHT THOUSAND THREE HUNDRED NINETY-TWO AND 86/100 PHILIPPINE PESOS (PHP138,392.86) to support the Tourism Development of Northwest (NW) Leyte, and further requesting that the Honorable City Mayor be granted the authority to sign and accept the said Deed of Donation for and in behalf of the Local Government Unit of Ormoc City (LGU-Ormoc), a photocopy of the approved Deed of Donation of which is hereto attached and made an integral part hereof;

WHEREAS, the DONOR is a capacity development program established through a Memorandum of Understanding between the Government of Canada and the Government of the Republic of the Philippines;

WHEREAS, the DONOR which is funded by the Department of Foreign Affairs Trade and Industry (DFATD) and is a collaborative Program of the Governments of Canada and the Philippines, the goal of the program being the fostering of efficient, responsive, transparent and accountable governance at all levels and the purpose being the reduction of poverty by strengthening local governance and supporting sustainable local economic development (LED);

WHEREAS, both DONOR and DONEE have agreed that the assets subject for donation be used solely to support the tourism development in NW Leyte, in relation to the implementation of its partnership with LGSP-LED and towards the goals stated above;

WHEREAS, in consideration of the above, the DONOR transfers by way of said donation to the DONEE the assets described in the attached Handover Checklist, identified as Attachment A in the Deed of Donation and which forms a part thereof, to hold the same unto the DONEE the said assets, absolutely and forever;

WHEREAS, the DONEE, in said deed of donation, accepts and receives the aforementioned donation and acknowledges with thanks to LGSP-LED and DFATD, as well as agrees that the assets will be used exclusively to support operations of the Program and to place and retain DFATD markings on the said assets for the duration of their useful lives;

WHEREAS, this Sanggunian unequivocally regards said Donation as a very admirable gesture of profound generosity by the Donor that will surely translate into immense benefits for the tourism development of NW Leyte and Ormoc City, and which must be accorded its immediate stamp of approval by granting authority to the Honorable City Mayor to sign and accept the same for and in behalf of LGU Ormoc, and equally importantly, its conveyance of warmth and sublime appreciation for such a benevolent act;

WHEREFORE, foregoing premises considered, on joint motion of Honorable SP Members Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, and Vincent L. Rama, Chairman, Committee on Tourism, severally seconded by Honorable SP Members Mariano Y. Corro, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, Antonio M. Codilla and Ruben R. Capahi; be it
