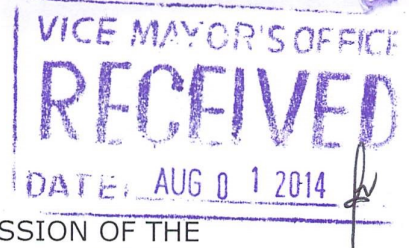

RESOLUTION NO. 2014-129

A RESOLUTION DECLARING ORDINANCE NO. 2014-004 OF BARANGAY DISTRICT XIII, THIS CITY, ENTITLED: "AN ORDINANCE PROHIBITING THE THROWING, PLACING OR DEPOSITING, SCATTERING OF GARBAGE, TRASH, WASTE AND AGGREGATES IN ANY PRIVATE VACANT LOTS OR HOUSEHOLD SORROUNDINGS (NOT OWNED OR POSSESSED), CANALS, STREETS, SIDEWALKS, AND PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF BRGY. DISTRICT XIII AND PROVIDING PENALTIES FOR VIOLATION THEREFORE" TO BE NOT INCONSISTENT WITH EXISTING LAWS AND CITY ORDINANCES AND INTERPOSING NO OBJECTION TO ITS IMPLEMENTATION AS AMENDED.

WHEREAS, this Sanggunian was in receipt of Ordinance No.2014-004 of Barangay District XIII, Ormoc City, entitled: "AN ORDINANCE PROHIBITING THE THROWING, PLACING OR DEPOSITING, SCATTERING OF GARBAGE, TRASH, WASTE AND AGGREGATES IN ANY PRIVATE VACANT LOTS OR HOUSEHOLD SORROUNDINGS (NOT OWNED OR POSSESSED), CANALS, STREETS, SIDEWALKS, AND PUBLIC PLACES WITHIN THE TERRITORIAL JURISDICTION OF BRGY. DISTRICT XIII AND PROVIDING PENALTIES FOR VIOLATION THEREFORE", a copy of the Ordinance is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the Ordinance was submitted to this Sanggunian pursuant to its review powers over enacted ordinances of all barangays within its territory as provided for in Section 57 of Republic Act No. 7160, otherwise known as the 'Local Government Code of 1991' (LGC) in order to find out whether the Ordinance under review is inconsistent with law or city ordinances;

WHEREAS, the Ordinance was enacted by the concerned barangay pursuant to its mandate of the promotion of health and safety in the barangay and the enhancement of the right of its people to a balanced ecology in accordance with Section 16 of the LGC;

WHEREAS, the Ordinance has a very noble and commendable primary goal in that it seeks to improve, ensure and support, among other things, the quality of life of the inhabitants of the concerned barangay;

WHEREAS, this Sanggunian, after thorough examination and review, found that the Ordinance under review is not inconsistent with existing applicable laws and city ordinances and, therefore, is interposing no objection to the implementation of the same provided that the word "Section 1" found in Article VI, Section 1 be changed to "Paragraph A";

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of Honorable SP Member Benjamin S. Pongos, Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Antonio M. Codilla, Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, Mario M. Rodriguez, Tomas R. Serafica and Mariano Y. Corro; be it


