RESOLUTION NO. 2014-137

*A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA), FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ORMOC (LGU-ORMOC), WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP), REPRESENTED BY MICHAEL RODRIGO I. MONDOY, SENIOR MANAGER, HEAD, ORMOC BRANCH FOR THE INSTALLATION AND OPERATION OF ONE (1) UNIT AUTOMATED TELLER MACHINE (ATM) AT THE GROUND FLOOR OF THE NEW ORMOC CITY HALL BUILDING.*

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Indorsement from the Office of the City Mayor dated October 17, 2013 relative to the MOA to be entered into by LGU-Ormoc with the DBP, represented by Michael Rodrigo I. Mondoy, Senior Manager, Head, Ormoc City Branch, (in the said Indorsement indicated then was Maria Consuelo A. Sosmena, the former DBP Acting Branch Head) and further requesting that the Honorable City Mayor be granted the authority to sign the said MOA, for and on behalf of LGU-Ormoc, for the Installation and Operation of One (1) Unit ATM at the ground floor of the New Ormoc City Hall Building, a photocopy of the final MOA and its annex is hereto attached as Annex "A" and made an integral part hereof;

WHEREAS, the DBP, in its desire to reach out to clients had launched a program aimed at bringing closer its products and services to them, particularly, by installing an ATM in areas other than its branch offices and, therefore, providing ATM services in said areas;

WHEREAS, the LGU-Ormoc and DBP do mutually acknowledge the need for an ATM to service the requirements of the LGU-Ormoc officials and employees, as well as visitors and other guests who wish to avail of said services, and have therefore decided to enter into an agreement for the installation and operation of one (1) unit of ATM at the New Ormoc City Hall premises located in Barangay Cogon, Ormoc City;

WHEREAS, the LGU-Ormoc, in further response to said DBP noble program, will allow the DBP to occupy free of charge a portion of the ground floor of the New Ormoc City Hall Building located in Barangay Cogon, Ormoc City, a total floor area of Ten (10) square-meters for one (1) unit ATM for a period of one (1) year but the parties to the MOA agree, however, that DBP shall shoulder the ATM monthly electricity consumption which is fixed at One Thousand Five Hundred Philippine Pesos (PhP1,500.00);

WHEREAS, the MOA clearly and definitively encapsulates the terms and conditions of the agreement of the parties thereto, including their specific obligations and responsibilities, towards the implementation and attainment of the lofty ends of the program, and this Sanggunian, upon thorough review and examination of the MOA, finds that the same will indeed significantly benefit the LGU-Ormoc officials and employees, as well as the visitors and other guests who wish to avail of DBP ATM services, and therefore, is most deserving of its favorable consideration;

WHEREFORE, on motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Tomas R. Serafica, Pedro Godiardo P. Ebcas, Mariano Y. Corro, Eusebio Gerardo S. Penserga and Vincent L. Rama; be it

RESOLVED, AS IT IS HERBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA), FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ORMOC (LGU-ORMOC), WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP), REPRESENTED BY MICHAEL RODRIGO I. MONDOY, SENIOR MANAGER, HEAD, ORMOC BRANCH FOR THE INSTALLATION AND OPERATION OF ONE (1) UNIT AUTOMATED TELLERING MACHINE (ATM) AT THE GROUND FLOOR OF THE NEW ORMOC CITY HALL BUILDING;


