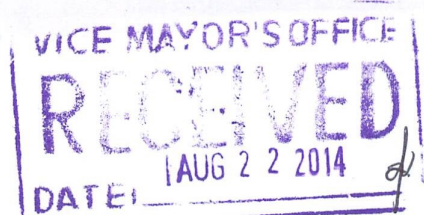

RESOLUTION NO. 2014-147

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE HELP - Hilfe zur Selbsthilfe e.V., REPRESENTED BY ITS HEAD OF MISSION, HENNING HILLMER, FOR THE IMPLEMENTATION OF THE HELP PROJECT TITLED REHABILITATION/REPAIR OF THE BAGSAKAN COMPLEX (AGRI-FISHERY SUPPLY AND TRADING CENTER) AT BARANGAY ALEGRIA, ORMOC CITY, WITH A TOTAL PROJECT COST OF UP TO SEVEN MILLION PHILIPPINE PESOS (PHP 7,000,000.00).

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an urgent Indorsement from the Office of the City Mayor dated August 8, 2014 relative to the preceding 1st Indorsement from the City Planning and Development Office (CPDO) Coordinator, Engr. Raoul E. Cam, recommending for the passage of a resolution authorizing the Honorable City Mayor to sign the MOU for and on behalf of LGU-Ormoc with the HELP - Hilfe zur Selbsthilfe e.V., represented by its Head of Mission, Henning Hillmer, for the implementation of the HELP Project-Rehabilitation/Repair of the Bagsakan Complex (Agri-Fishery Supply and Trading Center) at Barangay Alegria, Ormoc City, with a total project cost of up to SEVEN MILLION PHILIPPINE PESOS (Php7,000,000.00), a photocopy of the final MOU is hereto attached and made an integral part hereof;

WHEREAS, HELP is a German humanitarian and non-governmental organization that is independent of any private, financial or commercial interest and which action are guided only by requests from the population, by identified needs, and by the ability, willingness and potential that exist locally to respond the said needs, and which respects the principle of non-discrimination in all circumstances;

WHEREAS, the object of the MOU is to rehabilitate/repair the Bagsakan Complex (Agri-Fishery Supply and Trading Center) at Brgy. Alegria, Ormoc City, that was damaged by Super Typhoon Yolanda in order to:

- a.) provide a fully-operational facility where usual business activities can be efficiently conducted;
- b.) Strengthen the city's role as a major trading center in Region 8;
- c.) Provide a conducive economic environment for local and regional traders; and, Boost the local economy further;

WHEREAS, both parties mutually agreed to collaborate and coordinate for the rehabilitation and repair of the Bagsakan Complex at Barangay Alegria, Ormoc City, subject to the specific responsibilities of the concerned parties towards the achievement and implementation of the HELP Project, as stipulated in the MOU, and this Sanggunian, after close and thorough review of the same, finds that the MOU is hugely beneficial to the City, most especially to the benefitted local farmers, traders and other producers, as well as the buyers and consumers and so therefore, most deserving of its utmost support and favorable consideration;

WHEREFORE, on joint motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws & Ordinances and Honorable SP Member Pedro Godiardo P. Ebcas, Vice-Chairman, Committee on Infrastructure Development, severally seconded by Honorable SP Members Mariano Y. Corro, Vincent L. Rama, Antonio M. Codilla, Mario M. Rodriguez and Tomas R. Serafica; be it,


ADOPTED, August 19, 2014.
