APPROVING THE APPLICATION RESOLUTION PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE (PALC) UNDER PD 220 OF BELLAS SURVIVOR HOMEOWNERS ASSOCIATION, INC. A RESIDENTIAL 2.20 OF **BELLAS** SUBDIVISION PROJECT, COMPRISING LOT 2135-C, (LRC) PSD-08-019687-D, BEING A PORTION OF LOT 2135 OWNED BY TAN-MARTINEZ CORPORATION, LOCATED AT SAN ANTONIO, ORMOC CITY, COVERED BY BRGY. TRANSFER CERTIFICATE OF TITLE (TCT) NO. 45478 CONTAINING A NET PROJECT AREA OF TWENTY THREE HOUSAND EIGHT HUNDRED FIFTY SIX (23,856) SQUARE METERS MORE OR LESS CONSISTING OF ONE HUNDRED SEVENTY SIX (176) SALEABLE LOTS EXCLUDING ROAD COMMUNITY FACILITIES AND PARKS AND LOTS, PLAYGROUND.

WHEREAS, the Thirteenth Sangguniang Panlungsod ng Ormoc received a communication dated July 25, 2014 from the City Planning & Development Coordinator, Engr. Raoul E. Cam, forwarding the application for Preliminary Approval and Locational Clearance (PALC) under PD 220 of BELLAS SURVIVOR HOMEOWNERS ASSOCIATION INC., a Residential Subdivision Project located at Barangay San Antonio, Ormoc City;

WHEREAS, the proposed subdivision project comprises Lot 2135-C, (LRC) Psd-08-019687-D being a portion of Lot 2135 owned by Tan-Martinez Corporation, with a net project area of 23,856 sq. meters more or less covered by Transfer Certificate of Title (TCT) No. 45478 consisting of 176 saleable lots excluding road lots, community facilities and parks and playground;



WHEREAS, based on site inspection conducted by the City Planning and Development Office (CPDO) and evaluation of documents submitted it was found out that the subdivision project is already existing. The housing construction is already on going with compacted earth surface gravel overlay on the road network, some power lines are connected with water lines installed on houses in the area;
