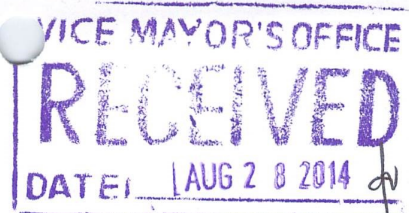
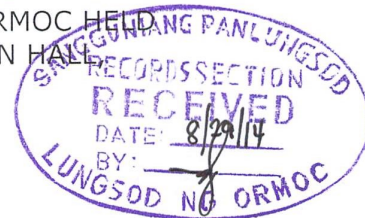

RESOLUTION NO. 2014-151

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE HELP - Hilfe zur Selbsthilfe e.V., REPRESENTED BY ITS HEAD OF MISSION, HENNING HILLMER, FOR THE IMPLEMENTATION OF THE HELP PROJECT TITLED REHABILITATION/REPAIR OF THE TRAINING CENTER-MANPOWER BUILDING (ORMOC CITY TECHNOLOGICAL MANPOWER AND TRAINING RESEARCH CENTER) AT AUNUBING STREET, ORMOC CITY, WITH A TOTAL PROJECT COST OF UP TO FIVE MILLION SEVEN HUNDRED FIFTY THOUSAND PHILIPPINE PESOS (PHP 5,750,000.00).

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an urgent Indorsement from the Office of the City Mayor dated August 15, 2014 relative to the preceding 1<sup>st</sup> Indorsement from the City Planning Development Office (CPDO) Coordinator, Engr. Raoul E. Cam, recommending for the passage of a resolution authorizing the Honorable City Mayor to sign the MOU for and on behalf of LGU-Ormoc with the HELP - Hilfe zur Selbsthilfe e. V., represented by its Head of Mission, Henning Hillmer, for the implementation of the HELP Project-Rehabilitation/Repair of Training Center-Manpower Building (Ormoc City Technological Manpower and Training Research Center) at Aunubing Street, Ormoc City, with a total project cost of up to FIVE MILLION SEVEN HUNDRED FIFTY THOUSAND PHILIPPINE PESOS (PHP 5,750,000.00), a photocopy of the final MOU is hereto attached and made an integral part hereof;

WHEREAS, HELP is a German humanitarian and non-governmental organization that is independent of any private, financial or commercial interest and which action are guided only by requests from the population, by identified needs, and by the ability, willingness and potential that exist locally to respond the said needs, and which respects the principle of non-discrimination in all circumstances;

WHEREAS, the object of the MOU is to rehabilitate/repair the Training Center-Manpower Building (Ormoc City Technological Manpower and Training Research Center) at Aunubing St., Ormoc City, that was damaged by Super Typhoon Yolanda in order to:

- a.) Continue providing the less privileged students acquire technical education;
- b.) Strengthen the city's role in producing quality middle-level manpower;
- c.) Provide a conducive learning environment; and,
- d.) Boost the city's employment rate;

WHEREAS, the parties to the MOU mutually agreed to collaborate and coordinate for the rehabilitation and repair of the Training Center-Manpower Building at Aunubing St., Ormoc City, subject to the specific responsibilities and commitments of said parties towards the achievement and implementation of the HELP Project as stipulated in the MOU, and that this Sanggunian, after close and thorough review of the same, finds that the MOU will immensely benefit the City, most especially the benefitted less privileged students, as well as the other constituents of this City, and so therefore, is most deserving of this Sanggunian's utmost support and favorable consideration;

WHEREFORE, on joint motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws & Ordinances and Honorable SP Member Rolando M. Villasencio, Chairman, Committee on Infrastructure Development, severally seconded by Honorable SP Members Mariano Y. Corro, Eusebio Gerardo S. Penserga, Pedro Godiardo P. Ebcas, Vincent L. Rama, Antonio M. Codilla and Mario M. Rodriguez; be it
