WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc recieved an Indorsement from the Office of the City Mayor dated July 21, 2014 relative to the preceding 1st Indorsement from the City Planning Development Office (CPDO) Coordinator, Engr. Raoul E. Cam, requesting for the passage of a resolution authorizing the Hon. City Mayor to implement projects under the Construction/Renovation/Improvement of Public Buildings and Facilities as per approved CY 2014 Annual Investment Program (AIP), chargeable against the 20% Development Fund, to wit;

WHEREAS, it can be recalled that this august Body has passed and approved SP Resolution No. 2013-081, entitled: A RESOLUTION APPROVING THE CY 2014 ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY OF ORMOC IN THE AMOUNT OF FOUR BILLION SEVENTY SEVEN MILLION EIGHT HUNDRED FORTY THOUSAND NINE HUNDRED EIGHT PESOS (P4,077,840,908.00) AS CONTAINED IN CITY DEVELOPMENT COUNCIL (CDC) RESOLUTION NO.2. SERIES OF 2013;

WHEREAS, the CY 2014 AIP contains the plans and priority projects of the city anchored on the needs of the Ormocanons Pre-Yolanda state. However, considering that majority of the government-owned buildings and infrastructures have been devastated and ravaged by super typhoon Yolanda, some of the plans and priority projects embodied in the CY 2014 AIP are no longer viable and needs to be redirected to respond the magnitude of damage caused by Yolanda;

WHEREAS, among the most heavily damaged key buildings of the city are the Jeepney and Bus Terminal. The immediate implementation of the repair and rehabilitation of said damaged buildings need to be undertaken hence, this request of the CPDO Coordinator for this Sanggunian to grant authority to the Honorable City Mayor Edward Codilla to implement the said projects under the Construction/Renovation/Improvement of Public Buildings and Facilities as per approved CY 2014 Annual Investment Program (AIP), chargeable against the 20% Development Fund, a photocopy of the final program of works of which is hereto attached and made an integral part hereof;

WHEREAS, this Sanggunian has considered the request as reasonable and that the immediate implementation of said projects will restore local governance and economic activities, and therefore, is most deserving of its favorable consideration;
