RESOLUTION NO. 2014-163

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A CONTRACT OF SERVICE FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF HEALTH (DOH), REPRESENTED BY ITS REGIONAL DIRECTOR, DR. JOSE R. LLACUNA, JR., AND MS. SHARMAIN GALENZOGA (MIDWIFE) FOR THE IMPLEMENTATION OF THE DOH RURAL HEALTH MIDWIVES PLACEMENT PROGRAM (RHMP).

WHEREAS, an Urgent Indorsement was received by this Sanggunian dated September 4, 2014 from the Office of the Honorable City Mayor Edward C. Codilla relative to the Contract of Service to be entered into by and among LGU-Ormoc, the Department of Health (DOH), represented by its Regional Director, Dr. Jose R. Llacuna Jr., and Ms. Sharmain Galenzoga, Midwife, and requesting that the Honorable City Mayor be granted the authority to enter into and sign the said Contract of Service for and on behalf of LGU-Ormoc, a photocopy of the final Contract of Service of which is hereto attached and made an integral part hereof;

WHEREAS, the R.A. 7160, otherwise known as the Local Government Code of 1991 (LGC), states that the function and responsibilities for the delivery of basic health services and other related facilities have been transferred from the DOH to the LGU;

WHEREAS, pursuant to its mandate to provide adequate and appropriate human resource for health in marginalized areas, the DOH shall deliver quality healthcare services in a devolved LGU such as LGU-Ormoc, including the management of clinical, administrative, and public health aspects;

WHEREAS, Ms. Sharmain Galenzoga, is a recipient of a 2-Year Midwifery Scholarship Program of the Philippines (MSPP) of the Department of Health (DOH) as per Executive Committee Resolution No. 112-232 Series of 2007 who had, pursuant to the same, agreed to serve and render a "Return Service";

WHEREAS, in pursuance of said "Return Service", Ms. Galenzoga will be assigned in Ormoc City, an identified priority area of the DOH, as a Rural Health Midwife (RHM) under the Rural Health Midwives Placement Program (RHMPP) for a period of Four (4) years upon her completion of the mentioned scholarship grant;

WHEREAS, the subject Contract of Service lays down the specific undertakings, obligations, and responsibilities of the parties thereon in furtherance of the "Return Service" of Ms. Galenzoga, and which "Return Service" as provided for in said contract, shall commence effective June 2, 2014, until December 31, 2014, renewable after every six (6) months of service;

WHEREAS, this Sanggunian finds the provisions of the Contract to be in order and that its implementation subject to the terms and conditions set forth therein, to be very beneficial to the City of Ormoc as it shall mean the engagement of the much-needed services of an additional midwife to augment the health midwives of the City, but whose salary shall nonetheless be paid by the DOH;

WHEREFORE, on joint motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, and Honorable SP Member Mario M. Rodriguez, Chairman, Committee on Health, severally seconded by Honorable SP Members Vincent L. Rama, Mariano Y. Corro and Ruben R. Capahi; be it,

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A CONTRACT OF SERVICE FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE DEPARTMENT OF HEALTH (DOH), REPRESENTED BY ITS REGIONAL DIRECTOR, DR. JOSE R. LLACUNA, JR., AND MS. SHARMAIN GALENZOGA (MIDWIFE) FOR THE IMPLEMENTATION OF THE DOH RURAL HEALTH MIDWIVES PLACEMENT PROGRAM (RHMPP);

ADOPTED, September 18, 2014.


