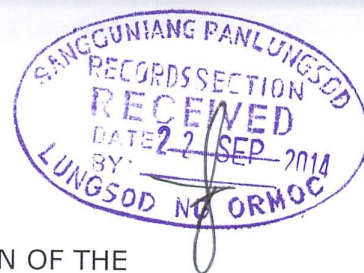

RESOLUTION NO. 2014-164

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO
CHARGE AGAINST THE CURRENT APPROPRIATION OF THE
CITY VETERINARY OFFICE, THE AMOUNT OF EIGHT
THOUSAND FOUR HUNDRED FIFTEEN PESOS (P8,415.00),
AS PAYMENT OF PRIOR YEAR'S SALARY DIFFERENTIAL OF
DR. AMANDO P. APODERADO, FORMER CITY
VETERINARIAN, AS AUTHORIZED UNDER SECTION 30 OF
RA 7305 (MAGNA CARTA FOR PUBLIC HEALTH WORKERS).

WHEREAS, an indorsement was received by this Sanggunian dated September 4, 2014, from the Office of the Honorable City Mayor Edward C. Codilla, relative to the request of Mrs. Adelaida H. Biacolo, HRMO IV, for the Payment of Prior Year's Salary Differential of Dr. Amando P. Apoderado, former City Veterinarian, in the amount of EIGHT THOUSAND FOUR HUNDRED FIFTEEN PESOS (P8,415.00) chargeable against current year appropriation of the City Veterinary Office;

WHEREAS, Dr. Apoderado retired from the public service as City Veterinarian effective February 7, 2014, and his entitlement to a salary differential is authorized under Section 30 of Republic Act No. 7305 otherwise known as Magna Carta for Public Health Workers which provides that: *"three (3) months prior to the compulsory retirement, the Public Health Worker shall automatically be granted one (1) salary grade higher than his/her basic salary and his/her retirement benefits thereafter computed on the basis of his/her highest salary, provided that he/she has reached the age and fulfilled service requirements under existing laws;"*

WHEREAS, Mrs. Adelaida H. Biacolo submitted a computation of the total appropriation required for the payment of Dr. Amando P. Apoderado's total salary difference for the period November 6-December 31, 2013, amounting to EIGHT THOUSAND FOUR HUNDRED FIFTEEN PESOS (P8,415.00);

WHEREAS, the City Budget Officer issued a Certification dated September 15, 2014 stating that the amount of EIGHT THOUSAND FOUR HUNDRED FIFTEEN PESOS (P8,415.00), may be charged against the Current Appropriation of the City Veterinary Office, to fund the aforesaid salary differential of Dr. Amando P. Apoderado;

WHEREAS, the City Treasurer, through a Certificate of Availability of Funds dated September 15, 2014, certified that the sum above requested is available from the Salary Savings under the Current Appropriation of the aforesaid office and the same may be used to cover the said salary differential as requested by Mrs. Biacolo;

FOREGOING PREMISES CONSIDERED, on motion of Honorable SP Member Mario M. Rodriguez, Chairman, Committee on Finance and Appropriation, jointly seconded by Honorable SP Members Antonio M. Codilla and Pedro Godiardo P. Ebcas; be it


