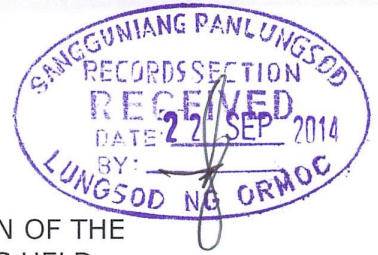

WHEREAS, Section 1 of Rule VIII of the Internal Rules of Procedure of the Thirteenth Sangguniang Panlungsod ng Ormoc provides that its Regular Session shall be held on every Thursday at exactly 2:00 o'clock in the afternoon;


