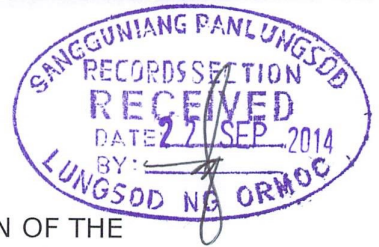

RESOLUTION NO. 2014-166

A RESOLUTION AUTHORIZING ORMOC CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REPRESENTED BY ITS REGIONAL DIRECTOR, NESTOR B. RAMOS FOR THE IMPLEMENTATION OF THE SUSTAINABLE LIVELIHOOD PROGRAM (SLP) IN ORMOC CITY.

WHEREAS, an Indorsement was received by this Sangunian dated September 04, 2014 from the Office of the City Mayor relative to the letter request of Ms. Marietta Legaspi, CSWDO, recommending the passage of a resolution authorizing the Honorable City Mayor to enter and sign the Memorandum of Agreement (MOA) by and between the City Government of Ormoc and Department of Social Welfare and Development (DSWD) Field Office VIII represented by its Regional Director, Nestor B. Ramos for the implementation of the Sustainable Livelihood Program (SLP) in Ormoc City, a photocopy of the final and revised MOA of which is hereto attached and made an integral part hereof;

WHEREAS, the Department of Social Welfare and Development is directed to provide social welfare and development programs, particularly through technical assistance and resource augmentation to continuously help alleviate poverty and ensure the welfare of the disadvantaged and vulnerable groups;

WHEREAS, Section 3 of the Republic Act 5416 otherwise known as the Social Welfare Act, further mandated DSWD to provide a comprehensive program of Social Welfare services designed to ameliorate the living conditions of the distressed Filipinos especially those who are handicapped by reason of poverty;

WHEREAS, to keep up the mandate and the substance of the aforementioned law, the DSWD has designed the Sustainable Livelihood Project (SLP) which focuses on promotions of viable peoples' organizations that effectively addresses the livelihood needs of the disadvantaged groups;

WHEREAS, the Sustainable Livelihood Program is a community-based capacity building program that seeks to improve the socio-economic status of program participants and enable the participants to manage sustainable micro-enterprises or link them to locally available jobs that will enhance their access to basic social services and improve their standard of living;

WHEREAS, during the Committee Meeting dated September 16, 2014, there was an observation in the Memorandum Of Agreement, particularly on the Witnesseth part of the First Whereas Clause on the cited provision of the Philippine Constitution Article XII, Section 1, an amendment by insertion should be applied at the end of the last words, "income and wealth", this phrase should be inserted, "a sustained increase in the amount of goods and services produced by the nation for the benefit of the people;

WHEREAS, another amendment by correction should be made in the Memorandum Of Agreement, particularly on the Witnesseth part of the Second Whereas Clause, by changing Article III into Article XIII;

WHEREFORE, on a joint motion of Honorable SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family, and Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, jointly seconded by Honorable SP Members Pedro Godiardo P. Ebcas and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING ORMOC CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REPRESENTED BY ITS REGIONAL DIRECTOR, NESTOR B. RAMOS FOR THE IMPLEMENTATION OF THE SUSTAINABLE LIVELIHOOD PROGRAM (SLP) IN ORMOC CITY;


ADOPTED, September 18, 2014.


