## RESOLUTION NO. 2014-168

RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA), FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE CHILDFUND PHILIPPINES INC., REPRESENTED BY ITS NATIONAL DIRECTOR KATHERINE L. MANIK, FOR THE IMPLEMENTATION OF ITS GRANT-FUNDED **EMERGENCY** LIVELIHOOD **PROJECT** *FOR* **TYPHOON** YOLANDA AFFECTED COMMUNITIES IN ORMOC CITY.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an urgent Indorsement from the Office of the City Mayor dated September 4, 2014 relative to the preceding 1st Indorsement of Ms. Marietta S. Legaspi, CSWD Officer, recommending therein for the passage of a resolution authorizing the Honorable City Mayor to enter and sign the Memorandum of Agreement (MOA) by and between the City Government of Ormoc and ChildFund Philippines Inc., represented by its National Director Katherine L. Manik, for the implementation of its grant-funded Emergency Livelihood Project for Typhoon Yolanda affected communities in Ormoc City, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the ChildFund Philippines, Inc. (Childfund) is a non-profit organization registered with the Securities and Exchange Commission (SEC) which objectives and goals emphasize the integration of maternal and child health, integrated management of childhood illnesses, and early childhood stimulation and development to ensure healthy beginnings for children in the Philippines;

WHEREAS, ChildFund exists to help deprived, excluded and vulnerable children have the capacity to improve their lives and the opportunity to become young adults, parents and leaders who bring lasting and positive change in their communities as well as promote societies whose individuals and institutions participate in valuing, protecting and advancing the worth and rights of children;

WHEREAS, ChildFund mobilizes global relationships linking children, sponsors, parents, teachers, community members, community leaders, local organizations, schools, local and national governments, foundations, corporations and in pursuance of the same, they will be implementing a grant funded project in the City of Ormoc to assist in the recovery of typhoon Yolanda affected communities back to normal situation;

WHEREAS, a Childfund grant funded project referred to as the "EMERGENCY LIVELIHOOD PROJECT" in the MOA shall be implemented in Ormoc City, and which is basically a livelihood training program whereby Childfund will generously provide manpower complement, training supplies, equipment, materials and resources in the fields of sewing craft, beauty care, carpentry and food processing to certain barangays in the City, and which shall be undertaken thru the coordination but minimal participation of LGU-Ormoc;

WHEREAS, the roles and responsibilities of the parties to the MOA, the Childfund and LGU-Ormoc, in the afore-described undertaking have been clearly encapsulated in the MOA which is to take effect from the date of the signing of the agreement up to the 31<sup>st</sup> day of December 2014;

WHEREAS, the parties have agreed to perform committedly their therein described respective roles and responsibilities with the goal of effectively implementing the Emergency Livelihood Project in Ormoc City, and thereby, efficaciously assisting the benefitted Yolanda-affected communities in Ormoc City in its recovery and development;

WHEREAS, this Sanggunian, after thoroughly reviewing the MOA and conducting further inquiries relative thereto, firmly concludes that the project object of the MOA will indeed significantly assist the benefitted Yolanda-affected communities in Ormoc City in its recovery and development, and for which reason, the MOA certainly deserves this august Body's full support and affirmative action;

WHEREFORE, on joint motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, and Honorable SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family, jointly seconded by Honorable SP Members Antonio M. Codilla and Pedro Godiardo P. Ebcas; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA), FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE CHILDFUND PHILIPPINES INC., REPRESENTED BY ITS NATIONAL DIRECTOR KATHERINE L.
