# RESOLUTION NO. 2014-173

RESOLUTION AUTHORIZING THE HONORABLE CITY YAYOR, EDWARD C. CODILLA, TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE DEPARTMENT OF AGRICULTURE (DA) AND THE CITY GOVERNMENT OF ORMOC, FOR THE IMPLEMENTATION OF THE PHILIPPINE RURAL DEVELOPMENT PROGRAM (PRDP) IN ORMOC CITY.

WHEREAS, on September 1, 2014, this Sanggunian received an indorsement dated August 22, 2014, from the Honorable City Mayor, Edward C. Codilla, requesting for an authority to sign the MOA between the Department of Agriculture (DA) and the City Government of Ormoc, for the implementation of the Philippine Rural Development Program (PRDP) in Ormoc City;

WHEREAS, on September 8, 2014, the Committees on Agriculture & Fisheries, and Laws and Ordinances, to which the aforementioned indorsement was referred to, were convened to discuss the aforementioned request of the City Mayor;

WHEREAS, during said meeting, it was found out that the submitted draft of the MOA has some deficiencies, principally the absence of the obligations/duties/commitments of the Department of Agriculture; hence, Dr. Cortes, the City Agriculturist, who was the sole resource person in said meeting, was requested to refer back the MOA to the Department of Agriculture for corrections, to which Dr. Cortes obliged;

WHEREAS, on September 16, 2014, Dr. Cortes submitted the revised MOA which now contained the requested corrections;

WHEREAS, Dr. Cortes in his aforementioned letter, copy of which is hereto attached for ready reference, alleged the justification/advantages/benefits which will accrue to the City Government of Ormoc through the adoption of the MOA;

WHEREFORE, foregoing premises considered, on motion of Ex-officio SP Member Mariano Y. Corro, the Vice-Chairman of the Committee on Laws and Ordinances, severally seconded by Honorable SP Members Tomas R. Serafica, Vincent L. Rama, Pedro Godiardo P. Ebcas and Eusebio Gerardo S. Penserga; be it –
