RESOLUTION NO. 2014-176

A RESOLUTION AUTHORIZING ORMOC CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD), REPRESENTED BY ITS REGIONAL DIRECTOR, NESTOR B. RAMOS FOR THE IMPLEMENTATION OF THE SUSTAINABLE LIVELIHOOD PROGRAM (SLP) UNDER ITS 2013 GRASSROOTS PARTICIPATORY BUDGETING (GPB) PROJECTS, FORMERLY KNOWN AS BOTTOM-UP BUDGETING (BuB).

WHEREAS, an Indorsement was received by this Sangunian dated September 11, 2014 from the Office of the City Mayor relative to the letter request of Ms. Marietta Legazpi, CSWDO, recommending the passage of a resolution authorizing the Honorable City Mayor to enter and sign the Memorandum of Agreement (MOA) by and between the City Government of Ormoc and Department of Social Welfare and Development (DSWD) Field Office VIII represented by its Regional Director, Nestor B. Ramos for the implementation of the Sustainable Livelihood Program (SLP) for fiscal year 2013 Bottom-up Planning and Budgeting (BUB), a photocopy of the final and revised MOA of which is hereto attached and made an integral part hereof;

WHEREAS, the Grassroots Participatory Budgeting Process (GPBP) is an approach to formulating the budget proposal of agencies, taking into consideration the development needs of poor cities/municipalities as identified in their respective local poverty reduction action plans that shall be formulated with strong participation of basic sectors and civil society organizations;

WHEREAS, the Protective Service Bureau (PSB), and Kapitbisig Laban sa Kahirapan -Comprehensive and Integrated Delivery of Social Services (KALAHI-CIDSS) and Sustainable Livelihood Program under the Poverty Reduction Programs Bureau (PRPB) as implementing arm of the Department shall lead the implementation of the approved GPB projects under its mandate;

WHEREAS, the Sustainable Livelihood Program (SLP) is a community-based capacity building program that seeks to improve the socioeconomic status of program participants and is an innovative approach to livelihood development and people empowerment;

WHEREAS, pursuant to the DBM, DILG, DSWD and NAPC Joint Memorandum Circular 02, series of 2012, issued on December 19, 2012, specifying the guidelines for the implementation and monitoring of BUB projects for FY 2013, both the DSWD and the Local Government Units and/or Civil Society Organizations shall uphold the principle of people empowerment even during the course of and post-project implementation;

WHEREAS, the DSWD, through the Regional Project Offices shall manage the review and assessment of projects and approval and disbursement of GPBP funds to the respective eligible LGUs and CSOs to implement the GPBP Projects as stipulated in the DSWD Administrative Order No. 48;

WHEREFORE, on a joint motion of Honorable SP Member Vincent L. Rama, Chairman, Committee on Social Welfare, Senior Citizens, Women and Family, and Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Antonio M. Codilla, Eusebio Gerardo S. Penserga, Mariano Y. Corro and Ruben R. Capahi; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass *A RESOLUTION AUTHORIZING ORMOC CITY MAYOR EDWARD C. 
