A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE NATIONAL MAPPING AND RESOURCE INFORMATION AUTHORITY (NAMRIA), REPRESENTED BYITS ADMINISTRATOR, **PETER** Ν. TIANGCO, **FOR** AVAILMENT OF GEOSPATIAL DATA NECESSARY IN THE PLANNING **PROCESSES** FOR REHABILITATION RECOVERY AND **PROJECTS** *FOR* POST-DISASTER SCENARIO.

WHEREAS, , an Urgent Indorsement dated September 25, 2014 was received by this Sanggunian from the Office of the City Mayor relative to the preceding 1st Indorsement from the City Planning Development Office (CPDO) Coordinator, Engr. Raoul E. Cam, recommending for the passage of a resolution authorizing the Hon. City Mayor to enter into and sign the MOU to be made by and between the City Government of Ormoc and the National Mapping and Resource Information (NAMRIA), represented by its Administrator, Peter N. Tiangco, relative to their intention to avail of geospatial data necessary in the planning processes for rehabilitation and recovery and projects for the post-disaster scenario, a photocopy of the final MOU is hereto attached and made an integral part hereof;

WHEREAS, NAMRIA as the central mapping agency of the national government, is the repository of digital base maps, aerial photographs, remotely sensed data and other related geographic information, and possesses the expertise in map making, geographic and resource information services;

WHEREAS, the City Government of Ormoc intends to avail of the products of NAMRIA to be able to undertake its program and projects and commits among others, to protect its interest by preventing the unauthorized use, proliferation, reproduction and sale of its products;

WHEREAS, the NAMRIA is willing to provide the City Government of Ormoc free of charge a one (1) DVD containing a copy of Interferometric Synthetic Aperture Radar (IFSAR) data comprising Digital Soil Mapping (DSM), Digital Terrain Model (DTM), Orthorectified Radar Intensity Image (ORI) files, contour with 5 meter elevation interval and satellite image after Typhoon Haiyan covering Ormoc City;

WHEREAS, considering the immediate need for such NAMRIA data and products, both parties agreed to collaborate and coordinate towards the achievement of said intention and goal, under the terms and conditions therein set forth, and this Sanggunian finds, after close and thorough review of the same, finds that the MOU is immensely beneficial to the City and so therefore, most deserving of its utmost support and favorable consideration;

WHEREFORE, on joint motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws & Ordinances and Honorable SP Member Rolando M. Villasencio, Chairman, Committee on Zoning, Housing & Land Use, severally seconded by Honorable SP Members Vincent L. Rama, Antonio M. Codilla, Eusebio Gerardo S. Penserga and Tomas R. Serafica; be it
