RESOLUTION NO. 2014-180

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGV-ORMOC), WITH THE PHILIPPINE INSTITUTE OF VOLCANOLOGY AND SEISMOLOGY (PHIVOLCS), REPRESENTED BY ITS DIRECTOR, DR. RENATO U. SOLIDUM, JR., FOR THE INSTALLATION OF AN INTENSITY METER IN ORMOC CITY.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an urgent Indorsement from the Office of the City Mayor dated September 25, 2014 relative to the preceding 4TH Indorsement of Mr. Bienvenido A. Matiga, DRRMO-designate and PAIAD Head, requesting therein for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to enter and sign the Memorandum of Agreement (MOA) by and between the Local Government Unit of Ormoc (LGU-Ormoc) and the Philippine Institute of Volcanology and Seismology (PHIVOLCS), represented by its Director, Dr. Renato U. Solidum, Jr., for the establishment of an Intensity Meter in Ormoc City, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, PHIVOLCS is a Philippine government agency mandated to avert disasters arising from geotectonic processes (earthquakes, and related geotectonic phenomena such as faulting, landslides and tsunami) and mitigate risks arising therefrom through formulation of up-to-date comprehensive disaster preparedness and loss reduction action plans;

WHEREAS, PHIVOLCS, aims to establish, operate and maintain a network of Intensity Meters strategically located in key areas of the country in order to record and make available online on near-real time basis, information on the severity of ground shaking due to various earthquake events;

WHEREAS, LGU-Ormoc, aware of the needs of PHIVOLCS to establish strategically located Intensity Meters in key areas of the country hence, aims to collaborate with the latter to gather these very important data that could be used for near-real time evaluation of impacts of earthquake events;

WHEREAS, considering the importance and benefits that such equipment can provide, the LGU-Ormoc expresses its consent and ratification to the installation of an Intensity Meter sometime in August 2014 in PAIAD Office which is inside the premises of the City Hall Building, free of cost for the use of the premises, the electrical consumption, and the internet connection with PHIVOLCS, however, shouldering the expenses incurred for the installation of the same;

WHEREAS, the MOA clearly and definitively encapsulates the terms and conditions of the agreement of the parties thereto, including their specific obligations and responsibilities, pertaining to the installation and use of subject instrument, and this Sanggunian, upon thorough review of the MOA, finds that the same will indeed significantly benefit the City most particularly in its pre-disaster preparedness and post-disaster responsiveness capabilities, and therefore, is most deserving of the august Body's prompt and favorable consideration;

WHEREFORE, on joint motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, and Honorable SP Member Rolando M. Villasencio, Vice-Chairman, Committee on Public Safety, severally seconded by Honorable SP Members Vincent L. Rama, Tomas R. Serafica, Antonio M. Codilla, John Eulalio Nepomuceno O. Aparis II, and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE PHILIPPINE INSTITUTE OF VOLCANOLOGY AND SEISMOLOGY (PHIVOLCS), REPRESENTED BY ITS DIRECTOR, DR RENATO U.
