RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE HELP - Hilfe zur Selbsthilfe e.V., REPRESENTED BY ITS HEAD OF MISSION, HENNING HILLMER, FOR THE IMPLEMENTATION OF THE HELP PROJECT ENTITLED "FOR PROVISION OF FISHING GEAR PROJECT BARANGAYS MACABUG, CAN-ADIENG, PUNTA, BANTIGUE, DANHUG AND SAN JUAN, ORMOC CITY", WITH A TOTAL PROJECT COST OF UP TO NINE HUNDRED EIGHTY THOUSAND PHILIPPINE PESOS (PHP 980,000.00).

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an urgent Indorsement from the Office of the City Mayor dated October 3, 2014 requesting therein for the passage of a resolution authorizing the Honorable City Mayor to sign a Memorandum of Understanding (MOU) for and on behalf of the City Government of Ormoc with the HELP - Hilfe zur Selbsthilfe e.V., represented by its Head of Mission, Henning Hillmer, for the implementation of the HELP Project for the Provision of Fishing Gear Project in Barangays Macabug, Can-adieng, Punta, Bantigue and Danhug, all in Ormoc City, with a total project cost of up to NINE HUNDRED EIGHT THOUSAND PHILIPPINE PESOS (PHP 980,000.00), a photocopy of the final MOU is hereto attached and made an integral part hereof;

WHEREAS, in a committee meeting conducted on October 14, 2014 regarding the MOU, the said Indorsement was discovered to have inadvertently failed to mention Barangay San Juan, the sixth of the benefitted barangays as resident fishermen therein will also be benefitted by the project, hence, the corresponding amendment including said barangay;

WHEREAS, HELP is a German non-governmental organization duly registered with the courts of law in Bonn, Germany providing humanitarian works in different countries;

WHEREAS, Help and the City of Ormoc have decided to enter into a MOU in order to collaborate for the provision of fishing gears consisting of nets, lines, hooks, and the likes, with an amount of up to NINE HUNDRED EIGHT THOUSAND PHILIPPINE PESOS (PHP 980,000.00), to fishermen residing in six (6) coastal barangays in Ormoc City which were damaged by the typhoch Yolanda with the end-goals of:

- a.) Enhancing the income generating activities of fishermen and their families affected by super-typhoon Yolanda; and,
- b.) To provide income for at least sixty-seven (67) fisher folks in the coastal communities by providing them with fishing gears to generate income for the beneficiaries.

WHEREAS, the said project will be organized, managed, and solely financed by HELP in close coordination and with direct support with the City Government of Ormoc thru the Agriculture Office-Animal Production and Fisheries Division and the City Fishery Aquatic Resource Management Council (CFARMC);

WHEREAS, both parties have mutually agreed to collaborate and coordinate for the implementation of afore-described project, subject to their specific roles and responsibilities towards the achievement and implementation of the HELP Project as stipulated in the MQU, and this Sanggunian finds, after close and thorough review of the same, that the MQU is immensely beneficial to the City, most especially to the benefitted fishermen and their families, and so therefore, is most deserving of its utmost support and favorable consideration;

WHEREFORE, on motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws & Ordinances and Vice-Chairman, Committee on Agriculture and Fisheries, severally seconded by Honorable SP Members Pedro Godiando P. Ebcas, Vincent L. Rama and Antonio M. Codilla; be it
