*A RESOLUTION ADOPTING THE ORMOC CITY RECOVERY AND
REHABILITATION PLAN AND APPROVING THE LIST OF
PROGRAMS AND PROJECTS TO BE IMPLEMENTED UNDER
THE SAID PLAN.*

WHEREAS, the Honorable City Mayor Edward C. Codilla through an Indorsement dated September 19, 2014 has endorsed to this august Body for appropriate legislative action the City Development Council (CDC) Resolution No. 1, entitled: "A RESOLUTION ADOPTING THE ORMOC RECOVERY AND REHABILITATION PLAN AND APPROVING THE LIST AND IMPLEMENTATION OF PROGRAMS AND PROJECTS UNDER THE SAID PLAN", a photocopy of the Ormoc Recovery and Rehabilitation Plan is hereto attached and made an integral part hereof;

WHEREAS, the said Ormoc City Recovery and Rehabilitation Plan was adopted from the UN-Habitat recovery planning framework which take into consideration the Shelter, Social Services, Economy (Livelihoods), Infrastructure and Environment;

WHEREAS, the framework likewise corresponds to the key policies and program initiatives of the Office of the Presidential Assistant for Rehabilitation and Recovery (OPARR) covering four (4) clusters: (i) Livelihoods and business development; (ii) housing and resettlement; (iii) social services; and (iv) infrastructure;

WHEREAS, a comprehensive set of projects and programs geared towards rebuilding Ormoc after the devastation of Super Typhoon Yolanda were laid down in the said Recovery and Rehabilitation Plan anchored on the Two (2) core drivers that could jumpstart and sustain the recovery efforts aimed at bringing total development of the city namely: agriculture and commerce;

WHEREAS, this Sanggunian after its thorough review and assessment, finds that the Ormoc City Recovery and Rehabilitation Plan absolutely addresses the priority needs of the City, the constituents and stakeholders; thus, this Body fully supports and concurs with the City Development Council's adoption of the said plan;
