GREEN VALLEY, ORMOO CITY IN THE AMOUNT OF P2,411,125.00, UNDER **■**ONSTRUCTION/REHABILITATION/IMPROVEMENT OF PUBLIC BUILDINGS & FACILITIES AS PER APPROVED CY 2014 ANNUAL INVESTMENT PROGRAM (AIP) UNDER SP RESOLUTION NO. 2013-081, DATED NOVEMBER 14, 2013 TO BE FUNDED FROM THE 20% DEVELOPMENT FUND.

WHEREAS, an Indorsement was received by this Sanggunian dated July 21, 2014 from the Office of the City Mayor relative to the request of Engr. Raoul E. Cam, City Planning & Development Coordinator, for the passage of SP Resolution Authorizing the Honorable City Mayor to implement projects under the Construction/Rehabilitation/Improvement of Public Buildings & Facilities of the Approved CY 2014 Annual Investment Program (AIP), chargeable against the 20% Development Fund, to wit:

WHEREAS, the immediate implementation of the Rehabilitation of the above mentioned projects need to be undertaken, hence, this request of the CPDO Coordinator for this Sanggunian to grant authority for the Honorable City Mayor to implement projects under the Construction/Rehabilitation/Improvement of Public Buildings & Facilities of the Approved CY 2014 Annual Investment Program (AIP), chargeable against the 20% Development Fund, a photocopy of the final program of works of which is hereto attached and made an integral part hereof;

WHEREAS, since one of the purpose of the said rehabilitation is for the Material Recovery Facility at Eco-Waste Center under item d, which is also a primary concern of the Committee on Environment and Natural Resources, chaired by this representation, I respectfully requested the Chairman of the Committee on Infrastructure Development, the Chairman of Committee on Laws and Ordinances and the Chairman of the Committee on Finance and Appropriation, to pull out item d and made it as a separate entry from the original request;

WHEREAS, it can be recalled that a quadripartite committee meeting was held last August 13, 2014 to take up this matter and it resulted in the suspension of the proceeding because there was a recommendation to consult first the City Mayor to decide whether the implementation of the said project could be done by administration or by contract;

WHEREAS, this Sanggunian has considered the request for rehabilitation, which will be undertaken through contract as per advise by the executive branch and has well thought-out that this immediate implementation will restore the environmentally sound means of waste disposal in our City, therefore, is most deserving of its favorable action;
