A RESOLUTION AUTHORIZING THE HONORABLE CITY

IN GENERIC TERMS, PROVIDED THAT A LIST OF  
IDENTIFIED AND PROGRAMMED INFRASTRUCTURE  
PROJECTS APPROPRIATED IN GENERIC TERMS FOR  
PARTICULAR MONTH BE SUBMITTED TO THE  
SANGGUNIANG PANLUNGSOD ON OR BEFORE THE 15<sup>TH</sup>  
DAY OF THE SUCCEEDING MONTH.

WHEREAS, the Thirteenth Sangguniang Panlungsod ng Ormoc received an Indorsement dated September 19, 2014 from the Honorable City Mayor Edward C. Codilla relative to the City Development Council (CDC) Resolution No. 4, Series of 2014, entitled: "A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C.
