A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE  
CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND  
SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND  
ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC  
(LGU-ORMOC), WITH THE IPI FOUNDATION INC.,  
REPRESENTED BY ITS EXECUTIVE DIRECTOR, LOURDES P.  
DAMAZO, FOR THE CONDUCT OF FREE DENTAL MISSIONS  
IN TWO (2) VENUES IN ORMOC CITY.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an urgent Indorsement from the Office of the City Mayor dated October 7, 2014 requesting therein for the passage of a resolution authorizing the Honorable City Mayor Edward C. Codilla to enter and sign the Memorandum of Agreement (MOA) to be made by and between the Local Government Unit of Ormoc (LGU-Ormoc) and the IPI Foundation, Inc., represented by its Executive Director, Ms. Lourdes P. Damazo, for the conduct of Free Dental Mission to the constituents of Ormoc City, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, IPI Foundation, Inc. (referred to as the "Foundation") is a foundation registered with the Securities and Exchange Commission (SEC) that provides providing medical and health care services to people in need of health care and medical attention;

WHEREAS, the Foundation is capable of rendering Free Dental Mission, with the following services, namely: Prophylaxis, Tooth Extraction, Filling, Fluoride Treatment, Dental Consultation and Dental Education, to the constituents of Ormoc City, the number of beneficiaries of which is dependent, among others, on the availability of volunteer dentists to be provided by the LGU-Ormoc and the Ormoc Dental Society, on the following venues and dates:

WHEREAS, LGU-Ormoc has committed to assist and collaborate in the Foundation's Free Dental Mission thru the provision of security, venues, volunteer dentists and recognition certificates to the Foundation as stipulated in the MOA, and to abide with the conditions appurtenant thereto;

WHEREAS, the concerned parties have agreed to carry out faithfully their roles and responsibilities in the MOA towards the successful conduct of the Free Dental Mission in accordance with the terms and conditions set forth therein, and this Sanggunian, after thorough examination of the MOA, clearly finds that it is indeed extremely beneficial to the underprivileged and indigent Ormocanons in need of dental services and therefore, most deserving of its utmost support and favorable consideration;

WHEREFORE, on joint motion of Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, and Honorable SP Member Mario M. Rodriguez, Chairman, Committee on Health and Sanitation, severally seconded by Honorable SP Members Pedro Godiardo P. Ebcas, Vincent L. Rama, Antonio M. Codilla and Eusebio Gerardo S. Penserga; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C.
