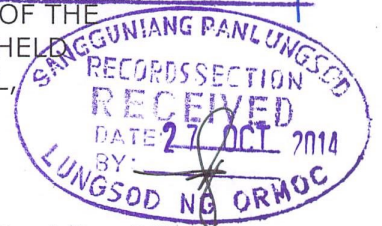

RESOLUTION NO. 2014-197

*A RESOLUTION AUTHORIZING ORMOC CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE HELP-HELFI ZUR SELBSTHILFE E.V., FOR THE IMPLEMENTATION OF ARTIFICIAL REEF PROJECT IN BARANGAYS IPIL, SAN ANTONIO AND NAUNGAN-LAO-SAN JUAN, ORMOC CITY.*

WHEREAS, this august body is in receipt of the Indorsement dated October 3, 2014 from the Office of the City Mayor relative to the request for the passage of a Resolution authorizing the Honorable City Mayor to enter and sign the Memorandum of Understanding (MoU) by and between the City Government of Ormoc and the HELP-Hilfe zur Selbsthilfe e.V., for the implementation of Artificial Reef Project in Barangays Ipil, San Antonio and Naungan-Lao-San Juan, Ormoc City, a photocopy of the final and revised MOU and its annexes is hereto attached and made an integral part hereof;

WHEREAS, when super typhoon Yolanda hit Ormoc City, the storm caused underwater damage, especially to the ecological marine habitat in the Marine Reserve Areas/Fish Sanctuaries in the said barangays of Ormoc;

WHEREAS, the Help - Hilfe zur Selbsthilfe e.V, a humanitarian and non-governmental organization (NGO) in close coordination with City Fisheries and Aquatic Resources Management Council (CFARMC) and Ormoc City's Agriculture Office- Animal Production and Fisheries Division, will be implementing Artificial Reef Project in three Coastal barangays in Ormoc City;

WHEREAS, said project will enhance the degraded marine habitat of the Three (3) Marine Reserve Areas/Fish Sanctuaries and will also provide additional income to at least 75 fisher folks in the coastal communities on the actual installation of the fabricated artificial reef structures;

WHEREFORE, on a joint motion of Honorable SP Member Vincent L. Rama, Chairman, Committee on Environment and Natural Resources, and Honorable SP Member Benjamin S. Pongos Jr., Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Mariano Y. Corro, John Eulalio Nepomuceno O. Aparis, II, Pedro Godiardo P. Ebcas, Antonio M. Codilla and Tomas R. Serafica; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass A RESOLUTION AUTHORIZING ORMOC CITY MAYOR EDWARD C. CODILLA, REPRESENTING THE ORMOC CITY GOVERNMENT, TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE HELP-HELFI ZUR SELBSTHILFE E.V., FOR THE IMPLEMENTATION OF ARTIFICIAL REEF PROJECT IN BARANGAYS IPIL, SAN ANTONIO AND NAUNGAN-LAO-SAN JUAN, ORMOC CITY;
