RESOLUTION NO. 2014-203

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (RENEWAL) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC THROUGH THE CITY HEALTH DEPARTMENT WITH SAN LORENZO RUIZ COLLEGE OF ORMOC, INC.(SLRC), REPRESENTED BY ITS VICE PRESIDENT, DR. ADELINA Y. LARRAZABAL, FOR THE AFFILIATION OF ITS MEDICAL TECHNOLOGY INTERNS.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc received an Indorsement dated October 10, 2014 from the Office of the City Mayor relative to the request of Ms. Ma. Lythlinda P. Palomino, Dean, College of Medical Laboratory Science of San Lorenzo Ruiz College of Ormoc, Inc. (SLRC) for the renewal of the Memorandum of Agreement (MOA) by and between the City Government of Ormoc and San Lorenzo Ruiz College of Ormoc, Inc. for the affiliation of its Medical Technology Interns with the City thru the City Health Department and further requesting for the passage of a resolution authorizing the Honorable City Mayor to sign the said renewal MOA;

WHEREAS, under the MOA the City Government of Ormoc thru the City Health Department (CHD), agrees that it shall make available the organized community health services at the San Pablo District Health Center for the necessary learning experience of the Medical Technology students of San Lorenzo Ruiz College of Ormoc, Inc. (SLRC) emphasizing the promotion of community, public and environmental health under the supervision of a licensed Medical Technologist who shall act as Clinical Instructor and will supervise and assist the students during their practicum at the said health center, subject to all the terms and conditions set forth in the agreement;

WHEREAS, the SLRC commits to abide with the terms and conditions covering the affiliation of its medical Technology Interns with the City Health Department during the conduct of their clinical training at San Pablo District Health Center;

WHEREAS, it can be recalled that there was a preceding MOA covering the matter, as embodied in SP Res. No. 2013-051 dated September 19, 2013 which duration is good for one (1) year only;

WHEREAS, in view of the coming expiration of the previous agreement on November 1, 2014, and considering that the concerned parties still desire to continue its partnership having acknowledged the relationship to be mutually beneficial to both the institution and the community, there is a need to renew the agreement concerning the matter;

WHEREAS, the said renewal of agreement covers a period of Three (3) years from November 01, 2014 to October 31, 2017, and may be renewed upon mutual behest of both parties;

WHEREAS, hence, the MOA stipulates the specific obligations and responsibilities of the concerned parties towards the achievement of its goals and objectives and therefore, most deserving of utmost support and favorable consideration;

WHEREFORE, on joint motion of Honorable SP Members Eusebio Gerardo S. Penserga, Vice-Chairman, Committee on Health and Sanitation and Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances, severally seconded by Honorable SP Members Mariano Y. Corro, John Eulalio Nepomuceno O. Aparis II, Vincent L. Rama, Pedro Godiardo P. Epcas, Antonio M. Codilla and Tomas R. Serafica; be it.


RESOLVED, FURTHER, that a copy of the final and notarized Memorandum of Agreement (MOA) be submitted to this Sanggunian for its information and files;
