

RESOLUTION NO. 2014-213

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU ORMOC) WITH THE DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE NO. 8 (DA-RFO 8), REPRESENTED BY ITS REGIONAL EXECUTIVE DIRECTOR, BERNADETTE F. SAN JUAN FOR THE PROVISION OF ONE (1) UNIT 4WD TRACTOR LGU TO ORMOC UNDER RECONSTRUCTION ASSISTANCE ON YOLANDA (RAY) PROGRAM.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an Indorsement from the Office of the City Mayor dated October 15, 2014 relative to the preceding 1st Indorsement from the City Agriculturist, Joseph C. Cortes, recommending for the passage of a resolution authorizing the Hon. City Mayor to sign the MOA for and on behalf of the Local Government Unit of Ormoc (LGU-Ormoc) with the Department of Agriculture Regional Field office No. 8 (DA-RFO 8), represented by its Regional Executive Director, Bernadette F. San Juan, for the provision of Farm Tractor to LGU-Ormoc under its Reconstruction Assistance of Yolanda (RAY) Program, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, DA-RFO 8 as the implementing arm in Region 8 of the Department of Agriculture, has been tasked to implement its Reconstruction Assistance on Yolanda (RAY) project which aim is to assist typhoon ravaged LGUs and communities to recover their agriculture and agriculture-related economic activities and enable farmers to start a new lease in life;

WHEREAS, LGU-ORMOC is in need of a Farm Tractor and has the administrative capability to manage and maintain said equipment to help farmers cultivate areas affected by Typhoon Yolanda and attain maximum yield through better and more effective land preparation technology, ensure the timely planting and cultivation of affected lands to consequently increase crop production and income of farmers;

WHEREAS, the provision of tractor is included in the third component (Farm Machinery and Equipment) of RAY program as per Supplemental Guidelines on the Rehabilitation of areas Affected by Typhoon Yolanda in Region 8 and Funds from DA were received by DA RFO 8 under ASA 101 2014-011 intended for the implementation of said RAY project;

WHEREAS, DA-RFO 8 finds the need to provide one (1) unit of 4WD Farm Tractor as one of the objectives of the rehabilitation to assist Local Governments and communities to recover the agriculture and agriculture-related economic activities, considering that rehabilitation of affected areas is urgent and indispensable for the survival of farming communities;

WHEREAS, as one of the recipients of the aforementioned FARM TRACTOR, LGU-Ormoc shall develop Policies and Operational Procedures on the implementation of the Tractor Provision Program which shall be considered as an integral part of this agreement;

WHEREAS, both parties are mutually committed in collaborating with each other for the successful implementation of the Tractor Provision Program, subject to the specific obligations and responsibilities of the concerned parties towards the achievement and implementation of the Tractor Provision Program of DA-RFO8, as stipulated in the MOA, and this Sanggunian finds, after close and thorough review of the same, that the MOA is extremely beneficial to the City, most especially to the benefitted local farmers, and producers, and so therefore, most deserving of its utmost support and favorable consideration;

WHEREFORE, on joint motion of Honorable SP Members Benjamin S. Pongos Jr., Chairman, Committee on Laws & Ordinances and Tomas R. Serafica, Chairman, Committee on Agriculture & Fisheries, severally seconded by Honorable SP Members Pedro Godiardo P. Ebcas, Vincent L. Rama, Antonio M. Codilla and Mario M. Rodriguez; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C.
