A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA), FOR AMD IN BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF LABOR EMPLOYMENT (DOLE), REPRESENTED REGIONAL DIRECTOR, ELIAS A. CAYANONG, FOR THE IMPLEMENTATION OF ITS LIVELIHOOD (KABUHAYAN) PROGRAM UNDER ITS INTEGRATED LIVELIHOOD EMERGENCY EMPLOYMENT PROGRAM (DILEEP).

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an urgent Indorsement from the Office of the City Mayor dated October 30, 2014 relative to the preceding communication from the City Social Welfare & Development Officer, Ms. Marietta S. Legaspi requesting therein for the passage of a resolution authorizing the Honorable City Mayor to enter and sign the Memorandum of Agreement (MOA) by and between the Local Government Unit of Ormoc and the Department of Labor and Employment (DOLE), represented by its Regional Director, Elias A. Cayanong, for the implementation of its Livelihood (KABUHAYAN) Program under its Integrated Livelihood Emergency Employment Program(DILEEP), a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, DOLE is a government office mandated to promote gainful employment opportunities, develop human resources, protect workers and promote their welfare, and maintain industrial peace, as well as endeavors to contribute to reducing poverty and vulnerability to risks of the poor, vulnerable, and marginalized workers by providing them access to livelihood undertakings;

WHEREAS, in order to carry out such mandate, the DOLE will provide a capacity building facility on livelihood and entrepreneurial ventures for the workers in the informal economy and the vulnerable groups of workers such as parents of child laborers, women, youth, persons with disabilities, indigenous peoples, among others, under the DOLE Livelihood (KABUHAYAN) Program;

WHEREAS, KABUHAYAN Program is a grant assistance for capacity-building on livelihood for the poor, vulnerable and marginalized workers. It provides a working capital solely for the purchase of equipments, tools and jigs, raw materials, among others, to be used in livelihood undertakings of the identified project beneficiaries;

WHEREAS, the DOLE-Regional Office No. 8 has been given the responsibility to implement the DOLE Livelihood (KABUHAYAN) Program and provide the fund assistance to LGU-Ormoc to be used exclusively for the implementation of the approved livelihood project as per project proposals submitted by the City Social Welfare and Development Office (CSWDO) appended hereto as annex "A", which forms an integral part of the MOA;

WHEREAS, LGU-Ormoc as an Accredited Co-Partner (ACP) of DOLE shall provide an equity or counterpart which is equivalent to at least twenty percent (20%) of the total project cost for the supervision and monitoring of the project or for other needs related to the project;

WHEREAS, the implementation of the approved LGU Kabuhayan Projects, shall be subject to the guidelines on the implementation of the Integrated Livelihood and Emergency Employment Programs (DILEEP) as per DOLE Department Order No. 137-14, Series 2014;

WHEREAS, the partnership of LGU-Ormoc and DOLE is vital to ensure the successful implementation of the identified projects and achieve their desired social outcomes, both parties as well agreed to perform committedly their therein described obligations and responsibilities with the goal of effectively implementing the Livelihood (KABUHAYAN) Program in Ormoc City to move the vulnerable groups of workers out from poverty and of making them productive;

WHEREAS, this Sanggunian, after thoroughly reviewing the MOA, firmly concludes that the project object of the MOA will indeed significantly assist the benefitted project beneficiaries, and for which reason, the MOA certainly deserves this august Body's full support and affirmative action;

WHEREFORE, on joint motion of Honorable SP Members Tomas R. Serafica, Chairman, Committee on Livelihood Development & Cottage Industry and Benjamin S. Pongos, Jr., Chairman, Committee on Laws & Ordinances, severally seconded by Honorable SP Members Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga and Mariano Y. Corro; be it
