RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) REGION VIII, REPRESENTED BY DILG-REGIONAL DIRECTOR, **PEDRO** Α. NOVAL JR., **FOR** IMPLEMENTATION OF THE TWO MILLION PHILIPPINE PESOS (PHP2,000,000.00) GRANT OF THE DILG UNDER THE SAGANA LIGTAS ATNA **TUBIG** SA LAHAT (SALINTUBIG) PROGRAM.

WHEREAS, this august Body was in receipt of an urgent Indorsement from the Office of the City Mayor dated November 13, 2014 relative to the preceding communication from the DILG-City Director, Ms. Lucia C. Ong, requesting therein for the passage of a resolution authorizing the Honorable City Mayor to enter and sign the Memorandum of Agreement (MOA) by and between the Local Government Unit of Ormoc (LGU-Ormoc) and the Department of the Interior and Local Government (DILG) Region VIII, for the implementation of the Two Million Philippine Pesos (PHP2,000,000.00) Grant of the DILG under the Sagana at Ligtas na Tubig sa Lahat (SALINTUBIG) Program, a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, the SALINTUBIG program aims to contribute to the attainment of the goal of providing potable water supply to all the Filipinos particularly for the poor and waterless communities consistent with the Philippine Development Plan 2011-2016 Millennium Development Goals (MDG) of the Aquino Administration;

WHEREAS, the SALINTUBIG is designed to provide grant financing and capacity development for the planning, implementation of water supply projects in waterless municipalities, poorest barangays with high level of waterborne diseases, resettlement areas and Rural Health Units without access to safe water;

WHEREAS, the said program is awarded to local government units (LGUs) that exercise good governance as a way of recognizing the best performances of LGUs and to further encourage them to further strive for and strengthen good governance practices;

WHEREAS, the DILG Memorandum Circular 06-2013, re: Operating Guidelines for the 2013 Provision of Potable Water provides that the LGUs will be Seal of Good Housekeeping (SGH) compliant;

WHEREAS, as implied in the communication of DILG-City Director Lucia C. Ong, the DILG had generated savings in the implementation of SALINTUBIG for CY 2013 thus, additional LGUs have been identified to avail of the same and among them is LGU-Ormoc as one of the priority recipients of the SALINTUBIG 2013 grant amounting to TWO MILLION PHILIPPINE PESOS (PHP2,000.000.00), however, the grant being part of DILG Savings for CY 2013 which will revert back to the General Fund if unused this year, to this effect, there is a need for the LGU-Ormoc to submit all the requirements for the availment of said grant to the Regional Office the soonest time possible;

WHEREAS, the SALINTUBIG grant will be utilized to implement the project entitled: "Water Supply Improvement Project for Various Barangays - Source Development and Pipeline Installation, Phase 1" covering Barangays Lake Danao, Milagro, Dolores, Luna, San Pabio and Hibunaon, all in Ormoc City;

WHEREAS, the MOA clearly stipulates the specific obligations and responsibilities of the concerned parties towards its achievement and underscores the all-important partnership of LGU-Ormoc and the National Government agency to contrive success in the project implementation, and this Sanggunian clearly finds the same not contrary to any law or public policy, and that the project subject thereof to be highly worthy and beneficial to the constituents of Ormoc, hence rendering the MOA to be most deserving, therefore, of this august Body's utmost support and favorable consideration;

WHEREFORE, on motion of Honorable SP Member Mariano Y. Corro, Vice-Chairman, Committee on Laws and Ordinances, severally seconded by Honorable SP Members Mario M. Rodriguez, Vincent L. Rama and Pedro Godiardo P. Ebcas; be it
