RESOLUTION NO. 2014-221

A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) FOR AND ON BEHALF OF THE LOCAL GOVERNMENT UNIT OF ORMOC (LGU-ORMOC) WITH THE FOLLOWING: THE ENERGY DEVELOPMENT CORPORATION (EDC), REPRESENTED BY ITS CHAIRMAN/CEO, FEDERICO R. LOPEZ; THE KANANGA-EDC INSTITUTE OF TECHNOLOGY EDUCATIONAL FOUNDATION, INC. (FOUNDATION), REPRESENTED BY ITS PRESIDENT, DR. PAUL A. AQUINO; AND, THE TECHNICAL EDUCATIONAL AND SKILLS DEVELOPMENT AUTHORITY (TESDA) REGION 8, REPRESENTED BY ITS REGIONAL DIRECTOR, CLETA M. OMEGA, FOR THE IMPLEMENTATION OF EDC'S EXTENSION SERVICE TRAINING PROGRAM.

WHEREAS, this Thirteenth Sangguniang Panlungsod ng Ormoc was in receipt of an urgent Indorsement from the Office of the City Mayor dated November 13, 2014 relative to the MOA to be entered into by and among the LGU-Ormoc, EDC, represented by its Chairman/CEO, Federico R. Lopez, KEITECH, represented by its President, Dr. Paul A. Aquino, and TESDA Region 8, represented by its Regional Director, Cleta M. Omega, and further requesting that the Honorable City Mayor be granted the authority to sign the said MOA for and on behalf of LGU-Ormoc for the implementation of EDC's Extension Service Training Program, a photocopy of the final MOA is hereto attached and made an integral part hereof;



WHEREAS, EDC is a private entity mandated to explore and develop alternative energy resources in the Philippines, and committed to provide assistance to communities living very proximate to its project sites through its Corporate Social Responsibility;

WHEREAS, EDC will provide an opportunity to economically and socially disadvantaged but deserving and qualified students in Ormoc City with short-term enhanced single qualification training from present to June 2016 for immediate employment through the Foundation which is the operator of the Kananga-EDC Institute of Technology (KEITECH), a post-secondary technical and vocational training center duly-accredited by TESDA located at Barangays Rizal and Hiluctogan, Municipality of Kananga, Province of Leyte;

WHEREAS, TESDA is the support agency to provide technical assistance in the formulation and implementation of the Foundation's development plan, skills development training and other technical support necessary to run and operate the Foundation;

WHEREAS, the Extension Service Training Program consists of short-term enhanced single qualification (Plumbing NC II, Carpentry NC II and EIM NC II with 40 persons per batch at three months duration per batch) to be facilitated by the Foundation which training can accommodate eight (8) students/applicants per batch for Seven (7) batches or a total of Fifty Six (56) students/applicants;

WHEREAS, the concerned parties are mutually committed in collaborating for the successful implementation of EDC's Extension Service Training Program, subject to the specific obligations and responsibilities of each party towards the achievement and implementation of the EDC's Program, as stipulated in the MOA, and this Sanggunian finds, after close and thorough review of the same, that the MOA is not contrary to law or public policy and to be extremely beneficial to the City, most especially to the benefitted students who will be afforded better opportunities of acquiring gainful employment after graduating from the KEITECH institution, and so therefore, most deserving of this august Body's utmost support and favorable consideration and for this, this august Body expresses its deep and full gratitude to EDC, the Foundation and TESDA for such profound benevolence and magnanimity;

WHEREFORE, on joint motion of Honorable SP Member Mariano Y. Corro, Vice-Chairman, Committee on Laws and Ordinances, and Honorable SP Member Mario M. Rodriguez, Chairman, Committee on Education, severally seconded by Honorable SP Members Vincent L. Rama, Pedro Godiardo P. Ebcas, Eusebio Gerardo S. Penserga, Antonio M. Codilla and Tomas R. Serafica; be it
