A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EDWARD C. CODILLA TO ENTER INTO AND SIGN THE TWO (2) MEMORANDUM OF AGREEMENTS (MOAs) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC (LGU-ORMOC), WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG), REPRESENTED BY ITS REGIONAL DIRECTOR, PEDRO A. NOVAL JR., FOR THE IMPLEMENTATION OF THE FOLLOWING RECONSTRUCTION ASSISTANCE FOR YOLANDA (RAY) PROJECTS TO BE FUNDED BY THE DILG, TO WIT:

WHEREAS, this Sanggunian received an Urgent Indorsement dated November 19, 2014 from the Office of the City Mayor relative to the Two (2) Memorandum of Agreements (MOAs) to be made by and between the City Government of Ormoc and the Department of the Interior and Local Government (DILG), represented by its Regional Director, Pedro A. Noval Jr., for the implementation of projects under the Recovery Assistance on Yolanda (RAY) – DILG Fund – Batch 2, in the amount of TWENTY MILLION PESOS (P20,000,000.00) for the Repair/Rehabilitation of City Hall (additional) and TWENTY NINE MILLION FIVE HUNDRED EIGHTY NINE THOUSAND THREE HUNDRED FIVE & 08/100 (P29,589,305.08) for the Reconstruction/Rehabilitation of various Barangay Facilities (Barangay Hall, Day Care Centers and Civic Centers), a photocopy of the final MOA is hereto attached and made an integral part hereof;

WHEREAS, to facilitate the return to normalcy of Local Government services and economic activities in the Yolanda-affected areas, the Department of the Interior and Local Government (DILG) established the Recovery Assistance on Yolanda (RAY) – DILG Fund which aims to reconstruct and rehabilitate/repair LGU administrative buildings, public markets, civic centers and barangay facilities with Build Back Better (BBB) design considerations to make them more disaster-resilient public infrastructures;

WHEREAS, the RAY-DILG Fund covers 171 cities/municipalities including their respective barangays, within the 50 km. radius typhoon path, identified by the Department of Science and Technology (DOST) as most affected by Typhoon Yolanda;

WHEREAS, Ormoc City, being one of the 171 most affected LGUs has been identified as a recipient of the RAY-DILG Fund;

WHEREAS, the aforesaid RAY-DILG Fund will be utilized exclusively to fund the Reconstruction and Rehabilitation of Yolanda-damaged barangay facilities in various barangays of Ormoc City with an allocation of up to TWENTY NINE MILLION FIVE HUNDRED EIGHTY NINE THOUSAND THREE HUNDRED FIVE PESOS & 08/100 (P29,589,305.08) and for the Repair/Rehabilitation of City Hall (additional) in the amount TWENTY MILLION PESOS (P20,000,000.00) to be implemented in accordance with the approved Program of Works (POW) covering the said projects;

WHEREAS, the MOA encapsulate the terms and conditions of the agreement of the parties thereto, including their specific roles and responsibilities, towards the implementation and attainment of the herein referred RAY Projects, and this Sanggunian, upon thorough review of the MOA, finds that the same will indeed immensely benefit the City of Ormoc, and therefore, is most deserving of its prompt favorable consideration;

WHEREFORE, on joint motion of Honorable SP Member Mariano Y. Corro, Vice-Chairman, Committee on Laws and Ordinances and Honorable SP Member Pedro Godiardo P. Ebcas, Vice-Chairman, Committee on Infrastructure Development, severally seconded by Honorable SP Members Vincent L. Rama, Antonio M. Codilla, Ruben R. Capahi, Mario M. Rodriguez, Tomas R. Serafica and Eusebio Gerardo S. Penserga; be it


